Western Colloid inspected the installed Fluid Applied Reinforced Roof System at the above referenced projects on September 3rd 2003.

The roof system termination at the perimeter has been sealed with a permanent elastic flashing compound and is an acceptable detail.

The size and the condition of the blisters and ridges in the existing cap sheet roof membrane warranted encapsulation as an alternative to compromising the integrity of the existing membrane.

All H.V.A.C. and penetration details have been properly installed.

Western Colloid has approved this application and will issue the requested warranty.
