SUGGESTED PROCEDURE: CABLE TELEVISION

I would like to make the following proposal with regard to procedures:

1. The Joint Study Committee should conduct weekly meetings to last no longer than two hours.
2. Staff and applicants should meet immediately to identify the following:
 - a. Policy issues to be initially addressed by the study committee.
 - b. Technical issues (to be handled initially by staff and applicants in a series of meetings between themselves; later to be reviewed by the Committee).
3. With regard to hearings:
 - a. ^{ok} A hearing schedule and topics on policy issues shall be developed by the staff and the applicants within the next week.
 - b. All applicants will be asked to submit, no less than three days prior to the hearing at which a particular subject will be discussed, written comments of a limited length. *Friday delivery*
 - c. The staff shall, if they deem desirable, develop a format for comments and require all applicants to submit their comments in the accepted format.
4. After all policy issues have been discussed the Committee will review any technical changes recommended by the applicants/staff.

5. No oral testimony will be taken during the initial drafting committee meetings.
6. The goal is to develop a complete first draft ordinance.
7. After development of a first draft ordinance the ordinance shall be either:
 - a. Reviewed again by the Joint Committee, or
 - b. Referred directly to the Council/Board.
8. Thirty days circulation of the first draft ordinance shall occur prior to any hearing - whether by Committee or the Council/Board.
9. Whether at the Committee or Council/Board hearing on the first draft ordinance, a formal hearing format shall be adopted. All applicants shall be requested to attend and shall be requested to formally present written and oral testimony on all aspects of the ordinance. Applicants will be provided table space in the meeting and shall be asked to speak in any rational order we can determine.
