### MINUTES:

Sam Jackson, Deputy City Attorney, was present to discuss the questions raised at the Committee meeting of July 28 relating to validity and enforcement of AB 2013. He passed out a staff report (copy attached) addressing those concerns. He stated that the information presented to the Committee on July 28th was misleading, as this bill applies to situations in which gang members were given additional sentencing if they were involved in gang-related activities. He said the bill is now on the Governor's desk, so any action taken by the City should be done as soon as possible. Chairman Kastanis suggested that this item be filed.

Margaret Allen, Worker's Compensation Manager from the Department of Personnel, was present to discuss this item. Committeemember Mueller asked Ms. Allen whether the City had taken a position on

any of the LaRouche initiatives. Ms. Allen stated that the City had opposed them. Ms. Allen said that the City has a position of following the Mayor's Task Force, and that the City does not discriminate against persons with AIDS. She explained that the City's position conflicts with Proposition 102 where confidentiality is concerned.

Committeemember Mueller stated that her position is that the City oppose Proposition 102. Chairman Kastanis said he recently read that there have been no health/AIDS clinics and services and no regulation and control, which are concerns of his. Committeemember Mueller expressed her feeling that the government has been slow to respond to the AIDS problem. Margaret Allen explained that current state law regulates health services regarding people who are infected.

Committeemember Mueller moved to recommend to full Council that the City oppose Proposition 102 relating to AIDS reporting, since it would take away confidentiality guarantees and because it conflicts with the Mayor's Task Force. Chairman Kastanis said that before he seconds this motion, he would like to know why staff didn't go the extra step to make a recommendation on this initiative. Donna Giles, Director of Personnel, said the reason staff didn't go further and make an actual recommendation is that they were requested to take an analysis position rather than to take sides. She said staff didn't have the time to put all the information together to make a recommendation at this time.

Chairman Kastanis said that in light of that, he feels the City should take no position on Proposition 102. Pope moved to take no position, Kastanis seconded the motion, and Mueller opposed the motion. The vote was 2-1 to take no position on Proposition 102. This will now go to full Council.

MINUTES:


Lt. Jim White of the Sacramento Police Department was present regarding this item. He explained at this time that a couple of things have come up since this matter has been brought forward, and that he would like to take it off the agenda until they can be resolved. He said that Councilmember Shore requested that knives be included in this ordinance, and the other situation is with firing ranges inside the City. This matter will be continued to a later meeting.

At this time, Chairman Kastanis brought to the Committee's attention the matter of the 29 propositions that are to be included on the November ballot. He asked the Committee whether they wanted to deal with all 29 propositions at regular meetings, or did they wish to be selective. Committeemember Pope stated his preference would be to stay out of it altogether. Mueller feels that the Committee should address only those the Committee is requested to take action on. Pope said that to address all 29 propositions could take hours; Mueller feels they won't be requested to deal with most of them. Kastanis asked the Committee secretary to provide him with a list of all 29 propositions, at which time he will check with each Committeemember as to their interest before setting the next agenda. He said he is inclined to stay away from all of them, but that sometimes it gives guidance to our constituents. Chairman Kastanis also stated that Proposition 73 relating to campaign contributions should be discussed, but that this would probably need to be a separate meeting to be scheduled in early November. The next meeting is scheduled for October 20, 1988.
