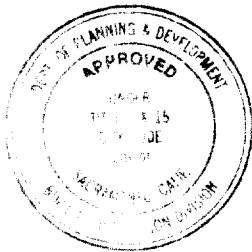

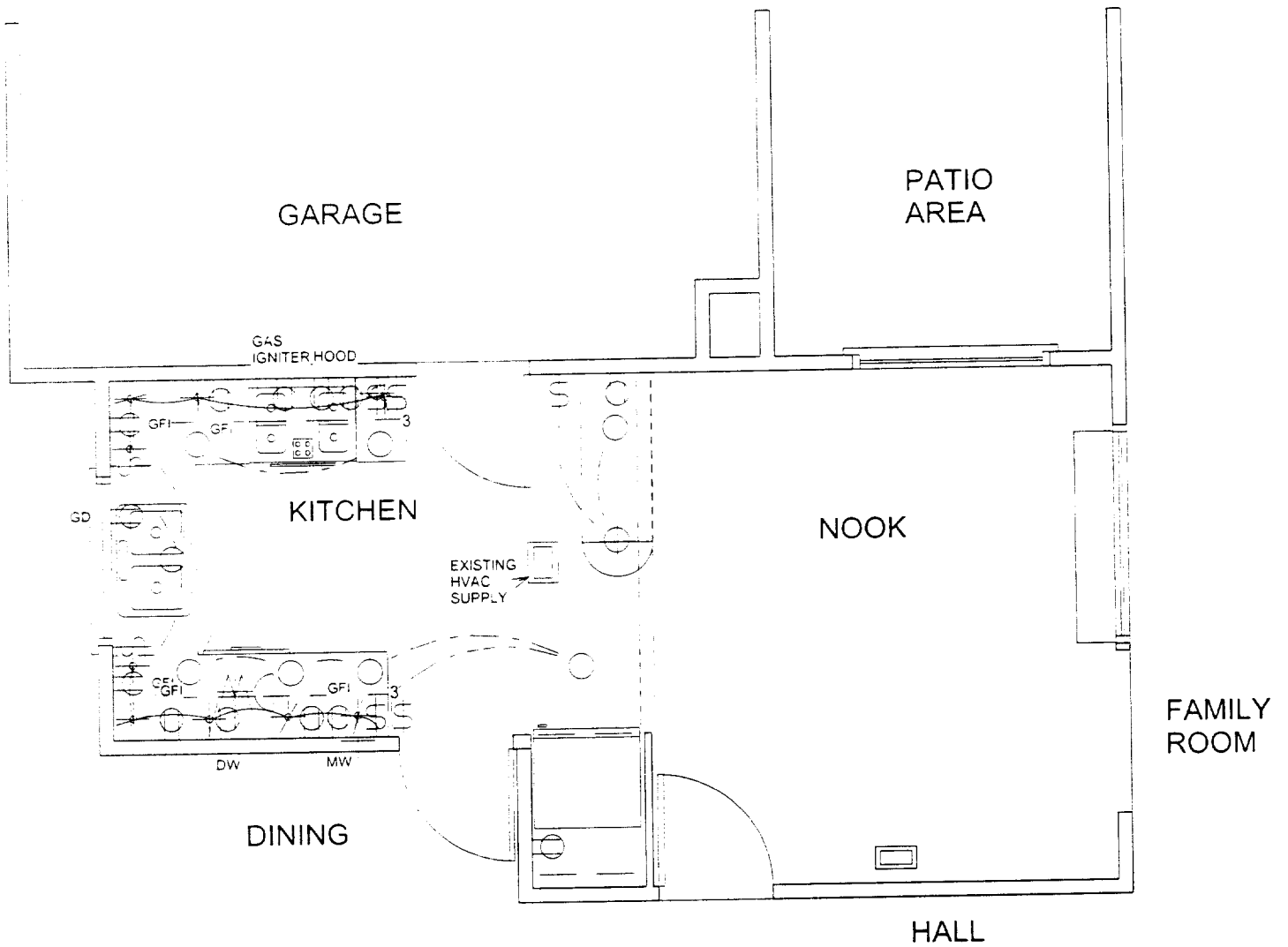
**TODRANK - NEW KITCHEN &
