

July 22, 1931.

The Civil Service Board of the City of Sacramento met in special session on the above date at 7:30 o'clock P. M. in the office of the Board, Room 106, City Hall, President Chenu presiding.

PRESENT: Commissioners Maloney, Weisman and Chenu.  
ABSENT: None.

The reading of the minutes of the previous meeting of July 2, 1931, was dispensed with.

Mr. L. F. Rushton from the Department of Architecture, of the State of California, was in attendance, upon the request of the Board, to assist in conducting the Personal Fitness and Oral Interview, for the classification of Plumber. The Board proceeded with the interview of candidates, fourteen candidates being interviewed.

Upon motion by Commissioner Weisman, seconded by Commissioner Maloney and unanimously carried, the following eligible list for the classification of Plumber was established; to be posted July 23, 1931, and effective August 7, 1931.

A resolution adopted by the City Council, July 16, 1931, was received requesting the postponement of the examination for Deputy City Controller.


