SUBJECT: Acquisition of Park Nodes in Riverbend Commons,

Pocket Canal Parkway

## SUMMARY

Adoption of two Resolutions to cover the expenditure of City funds for the acquisition of park nodes and payment for street improvements.

### BACKGROUND INFORMATION

On March 11th, 1980, the Council approved an amendment to the Capitol Improvement Budget for 1979-80 appropriating \$44,500.00 for acquisition of Lots C and K of Riverbend Commons for the Pocket Canal Parkway. The owner has agreed to sell said lots for the appraised value of \$25,726.86 with the City assuming the existing assessment and paying our pro-rata share of the cost of the streets now under construction.

The owner has signed an Acquisition Agreement and an Agreement For Reimbursement which cover the acquisition cost and payment for the street work fronting the proposed parkway.

## FINANCIAL DATA

The expenditure of \$33,500.00 to cover the acquisition and closing costs is to be expended from Park Development Fund, Budget No. 2-44-2240-2211-4813 and the expenditure of \$25,726.86 from Major Street Construction Fund, Budget No. 2-09-2600-2409-4820 for the construction of the street improvements fronting said parkway.


