SUBJECT: Sacramento Ridesharing Project

SUMMARY

This is an amendment to the agreement with the State of California and the City of Sacramento to cooperate in the Sacramento Ridesharing Project for the forthcoming fiscal year 1980-81.

BACKGROUND INFORMATION

The City of Sacramento has entered into an agreement dated October 6, 1976 with the State of California to cooperate in implementing the Sacramento Ridesharing Project for an additional one year period through the 1980-81 fiscal year. There is a mutual understanding that the termination date could be extended by consent of both parties.
