**SUBJECT:** COSUMNES RIVER BOULEVARD/CALVINE ROAD AT STATE  
ROUTE 99 INTERCHANGE PROJECT (PN:TJ86) - PROJECT  
APPROVAL AND BID ADVERTISEMENT OF STREET "A"

**LOCATION AND COUNCIL DISTRICT:** South Sacramento. Council District No. 8.

**RECOMMENDATION:**

This report recommends that the City Council:

- Approve the plans and specifications for the Street "A" project (see attached location map).
- Authorize the City Clerk to advertise for bids to be received on January 5, 1994.

**SUMMARY:**

The project is a two-lane road which will provide alternative access to existing vacant parcels adjacent to the proposed Cosumnes River Boulevard/Calvine Road at State Route 99 Interchange project. The construction of Street "A" will mitigate loss of access for existing parcels located easterly of Bruceville Road and southerly of Duluth Avenue.

Plans and specifications for the Street "A" project have been prepared. Approval of the plans and specifications and authorization to advertise for bids is recommended.

**COMMITTEE/COMMISSION ACTION:**

**BACKGROUND INFORMATION:**

Design is nearing completion for the proposed Cosumnes River Boulevard/Calvine Road at State Route 99 Interchange project. The project is scheduled for bid advertising in March 1994. Construction of Street "A" at this time is a high priority to provide alternate access to existing parcels.

The interchange project is a joint City/County, Measure A funded project which will include construction of a six-lane roadway across State Route 99 between Bruceville Road and Power Inn Road. As a result of the project, no driveway access will be available onto Cosumnes River Boulevard or Calvine Road due to Caltrans' access control requirements and traffic safety and circulation considerations.

Right-of-way negotiations are underway for the proposed interchange and Street "A" construction. It is anticipated that acquisition of all required right-of-way will be complete by the end of January 1994.

The City Council ratified the environmental negative declaration for the Street "A" project on June 15, 1993, Resolution No. 93-310.

**FINANCIAL CONSIDERATIONS:**

The engineer's estimated construction cost is \$89,000. Funding is available in the Cosumnes River Boulevard/Calvine Road at State Route 99 Interchange project (PN:TJ86) which had a balance of \$2,726,000 in Transportation Sales Tax funds as of November 2, 1993.

A non-refundable fee of \$25 will be charged for each set of plans and specifications to recover reproduction costs.

**POLICY CONSIDERATIONS:**

This action is consistent with Title 58, Chapter 58.03.301 of the City Code concerning advertisement for bids and Resolution No. 93-619 relating to MBE/WBE participation goals and policies adopted by the City Council on November 2, 1993.

**MBE/WBE:**

This project will include MBE/WBE participation goals of 10.57% MBE and 9.5% WBE as required by Resolution No. 93-619 relating to MBE/WBE participation goals


and policies adopted by the City Council on November 2, 1993. Award of contract will be contingent upon the responsive low bidder either meeting the project MBE/WBE participation goals or making adequate Good Faith Efforts towards meeting the project goals. Bids submitted which meet or exceed the MBE/WBE goals may be eligible for bid price preferences up to a maximum of 7% or \$25,000, whichever is lower.

Plans and specifications will be sent to seven (7) planrooms and construction services organizations for publication and use by the construction industry in Northern California. There are four (4) organizations on the distribution list that are directly involved with outreach to MBE/WBE contractors.

Other outreach efforts to MBE/WBEs for this project will include:


- Advertisement of the project on the City of Sacramento Construction Project Bid Line (916) 392-4758.
- Free access to review the project plans and specifications at the City of Sacramento Planroom at Engineering Division offices at 927 10th Street.
- Provide notice of this project to three minority chambers of commerce and three minority and women community organizations directly involved with outreach to MBE/WBEs.

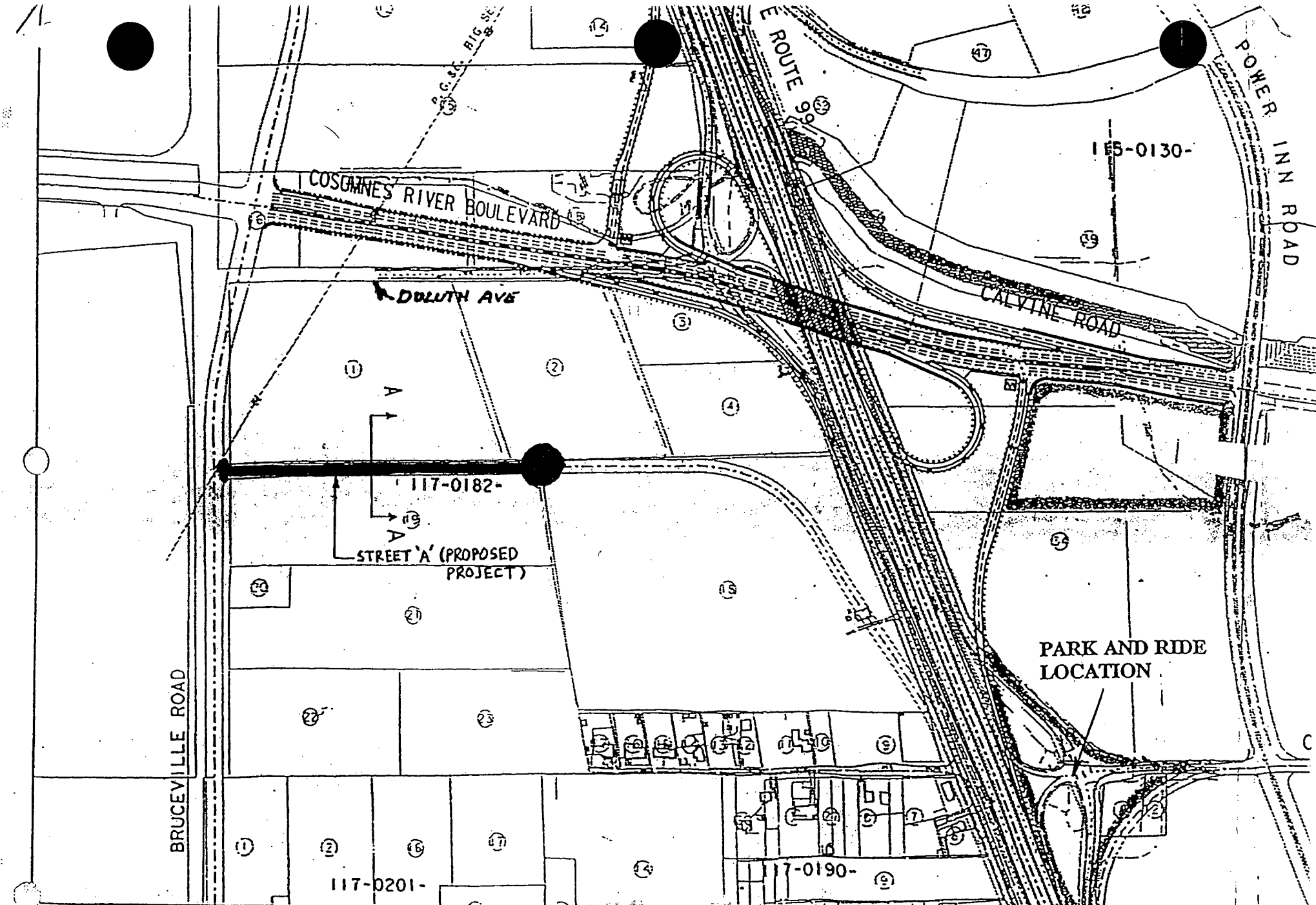

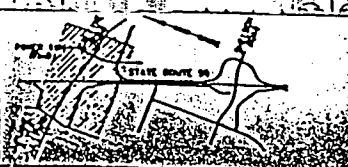

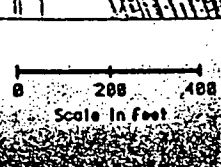


**SR 99 INTERCHANGES STUDY**
