Members of the Southside Park Neighborhood Association commented about Southside Park including recommending the addition of trees on the southern border to provide a screen from traffic and noise, and concerns about the condition of the lake, the restocking of fish in the lake, pesticide use in the park, trash pick up, and irrigation of trees. A representative from the Oak Park Neighborhood Association expressed dissatisfaction with the outcome of a meeting between Oak Park Community Center staff and citizens regarding the Center. Department staff will follow up on these issues.

STAFF REPORTS:

11. STATUS REPORT ON A SPORTS FIELD STUDY

Superintendent Alan Boyd reviewed the staff report and next steps in the study. Commissioners advised staff to discuss sports field use, types and gender of user groups, and field design and maintenance with both school principals and school athletic directors; to research how sports fields are actually being used which may affect field design, maintenance and/or renovation needs (such as school football fields being used for girls soccer). Partnering with user groups was encouraged, as well as engaging with user groups to provide volunteer support, funding and/or advocacy.

12. SUPPORT THE DRAFT *2006 PARKS AND RECREATION PROGRAMMING GUIDE*

Staff reviewed the community outreach process, the final draft guide and the top unfunded priority projects both regionally and by planning area. Staff commented that trends emerged in park and recreation facility needs including requests for more park safety lighting, park clubhouses, jogging paths, natural resource areas and assessments of park trees.

Commissioners discussed the overall planning, development and funding process as well as specific needs such as disabled access to park facilities, proposed school facilities, and specific needs and opportunities in the Pocket, Fruitridge, South Natomas, East Sacramento, Lemon Hill and other neighborhoods.

Chair Cooke recommended staff look into any measures to discourage dog owners from

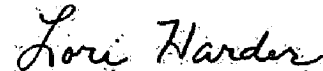
letting their dogs off-leash in parking lots and other park areas before entering an off-leash dog park.

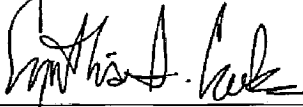
The Parks and Recreation Commission meeting adjourned at 9:10 p.m.
