ROBERT ROOT  
Appointed Chairman

Mr. Deise moved that Mr. Root be appointed Chairman of the Board vice Mr. Marty - term expiring; seconded

by Mr. Root and motion carried.

RECLASSIFICATION OF  
POSITION OF GARDENER  
TO SUB-FOREMAN - Water Div.

Communication from the Superintendent of the Water Division, requesting reclassification of the position of

Gardener at the Filtration Plant to Sub-Foreman, was considered.

In accordance with written report by the Secretary, submitting a job survey of said position and after determination that said position requires the supervision of from two to five laborers employed in various activities around the Filtration grounds, Mr. Deise moved that the position of Gardener be reclassified to Sub-Foreman, effective February 1, 1950; seconded by Mr. Root and motion carried.

After a general review and discussion, Mr. Deise moved that the detailed and physical standards for Firemen and Patrolmen as submitted by the Secretary, including authority for rejection by the City Physician and a revised medical application form for use in said examinations be adopted subject to the approval of the City Physician; seconded by Mr. Root and motion carried.

SERVICE RATING SYSTEM

The Secretary presented in booklet form a revised service rating system for use in the Police Sergeant and Fire Department - Engineer and Captain Examinations.

After discussion and review of said booklet, Mr. Root moved that the service rating system as submitted and as provided for by Section 46 of the City Charter be approved and made a part of the Civil Service Rules and Regulations; seconded by Mr. Deise and motion carried.
