SUBJECT: Assignment of Community Center Concession Agreement

SUMMARY

The staff requests that the Council authorize the City Manager to execute an agreement of consignment from Volume Services of California, Inc., to the present Interstate United Corporation, Hanson Industries, Inc., for the concession rights at the Community Center.

BACKGROUND

Through the bid process of the City, Volume Services of California, Inc., was awarded the concession rights at the Sacramento Community Center initially in 1974. By mutual option an extension of that agreement was made with Volume Services of California, Inc., to 1980.

The City elected to rebid in 1980 the concession agreement and the most responsible bidder chosen was Volume Services of California, Inc. This contract is for a period of five years. On June 19, 1978, Hanson Industries, Inc., purchased Interstate United Corporation and its subsidiaries. Now the corporation is reorganizing and taking their many contracts held by Interstate United Corporation subsidiaries and transferring them to the parent company, Hanson Industries, Inc. Hanson's name will ultimately be changed to Interstate United Corporation.

FINANCIAL IMPACT

There will be no financial impact with this name change. The change will only result in more assets available through the parent company. Effective upon assignment, they will assume all obligations.

RECOMMENDATION


