

SUBJECT: Section 8 Annual Contributions Contract Amendments Which Provide Replacement Funds and/or Extend the Term of the Existing Contract for the Housing Authority of the County of Sacramento and (2) Amend the Agency Budget to Incorporate the Additional Revenues

SUMMARY

This report authorizes the Executive Director to execute the Annual Contributions Contract (ACC) and to amend the Agency budget as needed. The ACC will be a replacement or extension of an existing ACC that expires on December 14, 1990.

BACKGROUND

Our Section 8 Program is divided into a number of segments by contracts. From time to time, contract terms expire. The U.S. Department of Housing and Urban Development (HUD) has notified the Agency that it should consider requesting the Governing Boards to delegate to the Executive Director the authority to execute Section 8 ACC amendments for replacement funding when necessary. The goal is to expedite the processing of ACC amendments and budgets once HUD receives the replacement funding. The funds may not be paid by HUD to the Public Housing Authority until they are incorporated into the ACC and budget of the Agency.

Annual Contributions Contract CA30-E005-008 is due to expire December 14, 1990. This ACC consists of the following Section 8 Certificates; 50 one bedrooms, 20 two bedrooms, 50 three bedrooms, and 12 four bedrooms. The original ACC was for a 15 year period. The U.S. Department of Housing and Urban Development will be providing replacement funding for five years in the form of an Amended ACC.
