SUBJECT: Proposed Revisions to Agency Fees and Charges Schedule

SUMMARY

This report recommends the addition or revision of standardized fees and charges for various Agency activities and services.

BACKGROUND

The Agency first implemented a Fees and Charges Schedule in 1983. While the large majority of the fees remained unchanged, the Schedule was revised in 1984 and again in 1985 and 1986 to reflect a few additions, deletions, and increases to the prior schedule. It is now necessary to revise the 1986 Schedule to reflect adjustments for the 1987 year.

The recommended changes are minor revisions to the current schedule. The attached listing (Exhibit A) shows the changes and additions to the existing 1986 Fees and Charges Schedule which has been in effect since March 11, 1986. This listing has been reviewed by the Resident Council and unanimously approved. Upon your approval, these changes will be added to the current 1986 Schedule, which will then become the 1987 Schedule which will be effective immediately. All other fees and charges currently in place will continue unchanged. During the 1987 year, if any new fee is proposed, or an existing fee is to be changed, staff will come before you with a resolution proposing to change the existing fee structure for that individual item.

FINANCIAL DATA

There will not be a significant impact on the financial condition of the Agency as a result of these proposed changes. The primary emphasis of this item is to:

- 1) Identify fees to potential users of Agency services;
- 2) Standardize fees as much as possible; and
- 3) Charge fees to cover the cost of providing services.

It is not intended to generate additional income. Maintenance fees are only charged to tenants for excessive "wear and tear". They are not charged for normal, routine maintenance.

ENVIRONMENTAL REVIEW

Environmental review is not applicable for this report.

POLICY IMPLICATIONS

The actions proposed in this staff report are consistent with previously approved policy and there are no policy changes being recommended.


