SUBJECT: Alta Valley Road and Bruceville Road Traffic Signal (Kaiser

Permanente Hospital) (CC:9753) - Fund Appropriation

SUMMARY

Kaiser Permanente Hospital has requested and offered to pay for, the installation of a traffic signal at Bruceville Road and Alta Valley Road. Acceptance of this offer and modification of the FY 1985/86 Public Works CIP is recommended. This item is also on the Council agenda of June 4, 1986.

BACKGROUND

Kaiser Permanente Hospital has requested the installation of a traffic signal at the intersection of Alta Valley Road and Bruceville Road. By following standard City policy, this intersection would have to compete with many other intersections throughout the City for the available signalization dollars in the City's Capital Improvement Program. In an effort to install a signal at this location in a shorter time frame, Kaiser Permanente Hospital has offered to pay for the installation of the traffic signal. To expedite the execution of the agreement between Kaiser and the City, this item is also being heard before the full Council on June 4, 1986.

FINANCIAL

It is estimated that the cost of this traffic signal will be approximately \$120,000. Kaiser has agreed to pay up to that amount and has executed an agreement to provide the full amount upon execution of the agreement by the City. Should the actual cost of this project exceed \$120,000, then the City will fund the remaining cost. If the project cost is less than \$120,000, any remaining funds will be reimbursed to Kaiser upon completion of the project.

Dear Mr. Popish:

Pursuant to your conversations with myself and Verne Garcia. Senior Electrical Engineer for the City, I have enclosed a draft agreement between the City and your client which would allow for private funding for the signalization of the intersection of Bruceville Road and Alta Valley Drive. Generally, once this agreement is entered into and adequate assurances for project funding are established, the City will begin the design of the proposed traffic signal.

It is estimated that the total project cost will be approximately \$120,000. If the funding is established within the next 30 days, the City estimates that the design will be complete in July of this year. This will allow for installation to be completed by the end of this calendar year.

RECITALS

WHEREAS, Kaiser desires to have a traffic signal placed at the intersection of Bruceville Road and Alta Valley Drive in Sacramento, California, and

WHEREAS, City recognizes the desirability and utility of such signal, and

WHEREAS, the City is not planning to place a signal at such intersection in the immediate future,

NOW, THEREFORE, the parties agree as follows:

- 1. The City hereby agrees to install a traffic signal at the intersection of Bruceville Road and Alta Valley Drive conforming to the currently used traffic signal specifications in the City and integrated into and made a part of the public traffic signal system of the City.
- 2. In consideration for installing this signal and in accordance with the terms of this contract. Kaiser agrees to pay the City the sum of One Hundred Twenty Thousand Dollars (\$120,000.00), payable on execution of this contract, receipt of which is hereby acknowledged.
- 3. The City shall using its own forces, design, plan and inspect the work of construction of said traffic signal, and the City shall, by using a competitive bid system, obtain a contractor to construct said signal, all for an estimated amount not to exceed One Hundred Twenty Thousand Dollars (\$120,000.00).
- 4. Kaiser shall have no obligation to maintain or in any other way be responsible for said signal. other than the construction cost thereof contained in this agreement.

5. In the event the cost of construction, including the City staff time as outlined in this agreement, differs from the estimated amount of One Hundred Twenty Thousand Dollars (\$120,000.00), then any remaining funds shall be reimbursed to Kaiser upon completion of the construction work.

RESOLUTION EMPOWERING THE CITY MANAGER TO EXECUTE AGREEMENTS AND AMENDING THE CITY BUDGET FOR FY 85/86 TO CONSTRUCT A TRAFFIC SIGNAL AT ALTA VALLEY ROAD AND BRUCEVILLE ROAD

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO THAT:

- 1. The City Manager is empowered to execute all agreements necessary to accept funds from Kaiser Permanente for the installation of a traffic signal at the intersection of Alta Valley Road and Bruceville Road.
- 2. The City Budget for FY 1986 is hereby amended by appropriating \$120,000 from the Capital Grant Contingency Fund (2-48) to the Public Works Budget (2-48-5100-9753-4820) for the purpose stated in paragraph 1 above.
