SUBJECT: Award of Contract for Water Main Installation
Folsom Boulevard 400' East of Julliard

SUMMARY

Bids for the subject project have been received and it is recommended the contract be awarded to the low bidder, Tatum and Sons.

BACKGROUND

On September 16, 1980 the City Council approved plans and specifications for the subject project and bids were received on October 7, 1980. The following bids were received:
