**SUBJECT: RECOMMENDATION FOR AWARD OF BID NO. 1560, STOCKLESS
OFFICE SUPPLIES SYSTEM, IN A TOTAL AMOUNT OF \$360,000.00**

SUMMARY

Attached is a tabulation of sealed proposals received by the City Clerk for furnishing material in accordance with specifications adopted by the City Council and recommendation of bid award for the following:

Stockless Office Supplies System for use by all City departments.

RECOMMENDATION

It is recommended that, in the City's best interest, the City Council accept the lowest responsible bid submitted per Chapter 57 of the Sacramento City Code, as follows:

Authorization is being requested to enter into a contract in an amount not to exceed \$360,000.00 per year, which more closely reflects the actual amount to be expended each year of this potential 5 year contract.



BACKGROUND

Specifications were adopted by the City Council on May 26, 1992 and bids were called for by the City Clerk on June 17, 1992.

On June 9, 1992, the Council authorized a six-month extension of the existing Stockless Office Supplies contract with Boise-Cascade in order to provide for a smooth transition of services in the event that a new vendor had competed successfully for the contract. However, since Boise-Cascade offered the lowest responsible bid the extension authorized will not be necessary, and the new contract terms can be put into effect immediately following Council's approval of the bid award to Boise Cascade.

FINANCIAL CONSIDERATIONS

Funds for this purchase are available from various approved City departments' operating budgets.

POLICY CONSIDERATIONS

These recommendations are consistent with the requirements for competitive bidding as detailed in Chapter 57 of the Sacramento City Code.


MBE/WBE
