MINUTES OF CIVIL SERVICE BOARD
CITY OF SACRAMENTO

October 20, 1942

The Civil Service Board met in special session in its office at 5:00 P.M.

MINUTES, READING OF

Minutes of meeting July 23, July 30
and August 21, 1942, were ordered
approved as read.

GLORIA SOARES

Miss Soares, an employee of the Municipal Court appeared for interview with the Board. After determining Miss Soares' qualifications and reviewing her past experience, Mr. Deise moved that her temporary appointment as of August 11, 1942, for the position of Junior Stenographer-Clerk for employment in the Municipal Court be approved; seconded by Mr. Cavanaugh, thereupon becoming the order of the Board.

PHILIP HOLLAND

Mr. Cavanaugh reported that Mr. Holland and Carl Hoskinson, Superintendent of the Water Department and himself discussed the question of Mr. Holland's employment as Pump Operator with the City

Manager. Mr. Cavanaugh reviewed this discussion and after discussion by the Civil Service Board and agreement, it became the order of the Board that Rule VIII Section 2 relating to seniority, applied to this particular case.

ROBERT H. PLUMB

A letter from E. B. Chappell, Superintendent of the Corporation Yard, dated September 3, 1942, requesting the Board to change Mr. Plumb's classification from Junior Clerk to Senior Clerk, was considered by the Board. After discussion, the matter was continued pending investigation of Mr. Plumb's duties, and an additional report from City Engineer.

QUINTEN D. HAZEN
Classification

A letter from Herbert F. True, M.D., City Health Officer, dated May 29, 1942, was considered by the Board August 21, 1942 requesting that Mr. Hazen be listed as a Technician, was considered by the Board. After discussion, the matter was continued, pending receipt of classification study now under way by the City Manager.

WAR EMERGENCY EMPLOYMENT

After discussion relating to difficulty of securing candidates for examinations, appointments from lists, and demands upon the office, Mr. Deise moved that the following resolution be approved; seconded by Mr. Cavanaugh, thereupon becoming the order of the Board:

RESOLUTION

Approved October 20, 1942

WHEREAS, due to existing war emergency, candidates for examinations have not appeared in sufficient numbers, and

WHEREAS, existing eligible lists have become inadequate to supply sufficient names for appointments,

NOW, THEREFORE, BE IT RESOLVED that upon appointment by a department head and the City Manager, the Civil Service Board may consider approval of temporary appointments to positions for which eligible lists are inadequate, and

BE IT FURTHER RESOLVED that no Civil Service status is to accrue to the benefit of temporary appointees made under such conditions, and

BE IT FURTHER RESOLVED that at such time as City employees receive such temporary appointments, such employee shall be so notified and/or sign the temporary appointment.

RAY W. JONES

A letter from C. M. Hoskinson, Acting Superintendent of the Water Department dated October 20, 1942, was considered by the Board. Mr. Hoskinson discussed changes in duties performed by Mr. Jones and recommended that his classification be changed to that of Junior Engineer. The matter was continued pending investigation of Mr. Jones' duties.

WILLARD R. KERSH
Classification

A letter from F. N. Evans, Superintendent of Parks, dated June 29, 1942, requesting change of classification for Mr. Kersh to Senior Clerk was considered by the Board.

After review of duties being performed by Mr. Kersh, Mr. Deise moved that the position now held by Mr. Kersh be deemed to be that of a Senior Clerk; seconded by Mr. Cavanaugh, thereupon becoming the order of the Board.

After further discussion and review of Mr. Kersh's usual occupations, Mr. Deise moved that Mr. Kersh be reclassified from Junior Clerk to Senior Clerk; seconded by Mr. Cavanaugh, thereupon becoming the order of the Board.

W. P. STEPHAN

The Board considered Mr. Stephan's application for leave of absence while attending a school of medicine at the University of California. The Board also considered a letter from Mr. E. C. Goldsworthy dated September 17, 1942, certifying that Mr. Stephan was a student in the Medical School undergoing training.
