SUBJECT: Resolution Endorsing a New Freeway East and South of the City
Connecting I-80, US-50, US-99 and I-5

SUMMARY:

The attached report was referred to the Transportation and Community Development Committee by the City Council on January 15, 1985.

BACKGROUND:

Caltrans has identified a general route for a "bypass" freeway connecting the other freeways of the area. The County Board of Supervisors has adopted a resolution requesting the State Legislature to improve state highway access in Sacramento County by reinstating the necessary routes to provide the bypass freeway. The County Public Works Department has asked the City to adopt a similar resolution endorsing the freeway.

FINANCIAL DATA:

The present proposal is only to establish state numbered routes and study locations for possible future construction so there should be no financial impact on the City.

SUBJECT: Resolution Endorsing a New Freeway East and South of the City
Connecting I-80, US-50, US-99 and I-5

SUMMARY:

CalTrans has identified a general route for a "bypass" freeway connecting the other freeways of the area. The County Board of Supervisors has adopted a resolution requesting the State Legislature to improve state highway access in Sacramento County by reinstating the necessary routes to provide the bypass freeway. The County Public Works Department has asked the City to adopt a similar resolution endorsing the freeway.

BACKGROUND:

About ten years ago a network of freeways intended to serve the future travel needs of the Sacramento Metropolitan Area were abandoned. All plans for freeway construction were dropped and the rights-of-way that had been acquired were sold. One set of these freeways would have provided a bypass to the East and South of the central area with a North-South freeway between Watt Ave and Sunrise Blvd and an East-West freeway about a mile South of Mack Rd. Developments that have occurred during the past 10 years have made it almost impossible to consider reinstating these particular freeway alignments. Therefore, recent studies have considered a freeway alignment that is further from the central area. These studies have been very general and preliminary and only consider a freeway somewhere within the shaded area on the attached map.

It is likely that the bypass freeway would be constructed outside the Sacramento City limits. However, it should relieve traffic flows on I-80, US-50, US-99 and I-5 in and around the central area. To the extent that it does so, it could also relieve overloading on the surface streets caused by traffic trying to avoid freeway congestion.

It is highly unlikely that the type of movements that would use the bypass freeway could ever be served with Public Transit. The freeway would serve long distance travel through the area, trips between suburban areas and trips between the suburbs and destinations outside of the area. It would not serve travel to the central area where transit is a viable alternative to automobile travel.


FINANCIAL DATA:

1. The concept of a bypass connecting routes I-80, US-50, US-99 and I-5 East and South of the City is endorsed.

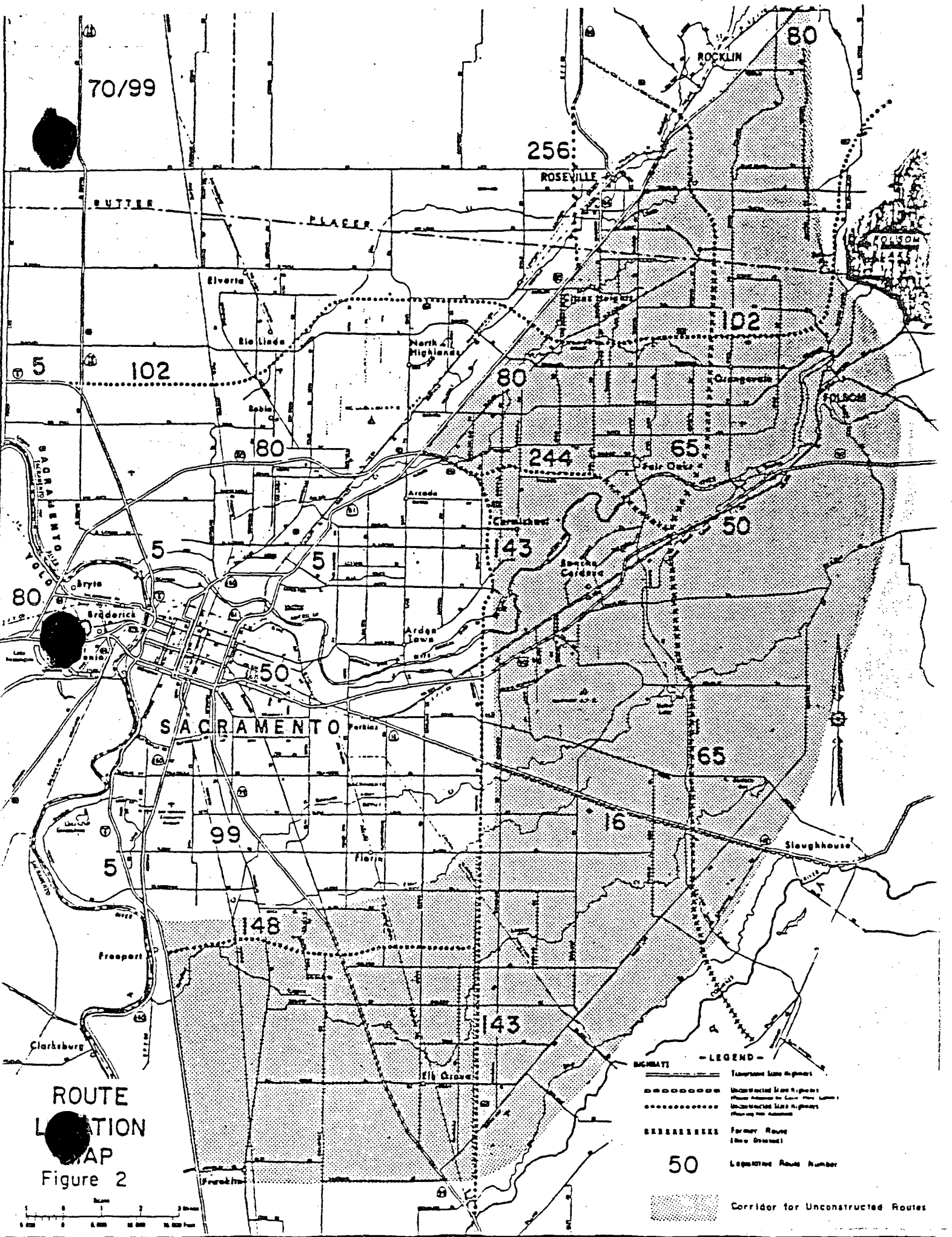
2. The Legislature of the State of California is requested to reinstate the appropriate highway routes for such a freeway.



RESOLUTION NO. 84-1458

RESOLUTION OF THE BOARD OF SUPERVISORS, COUNTY OF SACRAMENTO, STATE OF CALIFORNIA, IN SUPPORT OF EXTENDING STATE HIGHWAYS WITHIN SACRAMENTO COUNTY

WHEREAS, the County of Sacramento has studied the need for road improvements in its east county area, and is concerned about improving State highway traffic circulation in the South and East portion of Sacramento County; and

WHEREAS, The City of Roseville is concerned about severe traffic congestion on Douglas Boulevard and Sunrise Boulevard; and

WHEREAS, the County of Placer is concerned about severe traffic congestion on Douglas Boulevard and increasing traffic problems on Sierra College Boulevard and Auburn-Folsom Road; and

WHEREAS, the City of Folsom is currently studying the need for an additional crossing of the American River; and

WHEREAS, El Dorado County has determined that a need exists for major road improvements in the El Dorado Hills area; and

WHEREAS, there is a great need for joint study, planning, and implementation of road connections between and through each jurisdiction consistent with projected traffic needs; and

WHEREAS, Caltrans-District 3's Draft Route Concept Report of June 1984, identified substantial needs in the South and East areas of the County.

NOW, THEREFORE, BE IT RESOLVED that the Board of Supervisors of the County of Sacramento requests that the Legislature of the State of California take under consideration appropriate changes in the State Highway System to provide for improved State Highway access in Sacramento County.

BE IT FURTHER RESOLVED that the Legislature reinstate Route 65 in Sacramento County, from Route 104 to the Sacramento-Placer County Line, and extend Route 148 easterly to connect with Route 65.

BE IT FURTHER RESOLVED that copies of this Resolution be sent to all the members of the State Senate and Assembly representing Sacramento County in the State Legislature; Leo Trombatore, Director of the Department of Transportation; and members of the California Transportation Commission.

On a motion by Supervisor BRYAN, seconded by Supervisor SMOLEY, the foregoing Resolution was passed and adopted by the Board of Supervisors of the County of Sacramento, State of California, this 20th day of November, 1984, by the following vote
