Title: Contract: Broadway and Martin Luther King Jr. Boulevard Intersection Improvements Project (T15036100)

Location/Council District: Intersection of Broadway and Martin Luther King Jr. Boulevard (District 5). Location map – Exhibit A of Resolution.

Recommendation: Adopt a **Resolution:** 1) approving Plans and Specifications for the Broadway and Martin Luther King Jr. Boulevard Intersection Improvements Project (T15036100); and 2) awarding the contract to Martin General Engineering for an amount not to exceed \$670,746.

Description/Analysis

Issue: The project will improve pedestrian access and safety and relieve traffic congestion. The project consists of removing and replacing existing curb, gutter, and sidewalk on Broadway, widening Broadway at the intersection of Martin Luther King Jr. Boulevard, upgrading ADA ramps, and modifying the traffic signal at the intersection of Broadway and Martin Luther King Jr. Boulevard. The project was advertised and bids were received on January 21, 2010. Martin General Engineering is the lowest responsive and responsible bidder (see Attachment 1). City Council approval is necessary to award a construction contract.

Policy Considerations: The action requested herein is consistent with the Sacramento City Code, Title 3 and with the City of Sacramento Strategic Plan goals of achieving sustainability and neighborhood livability.

Environmental Considerations:

California Environmental Quality Act (CEQA): The Community Development Department, Environmental Planning Services Division has reviewed this project and determined that it is exempt from the provisions of the California Environmental Quality Act (CEQA) under Class 1, Section 15301(c), Class 2, Section 15302(c), Class 3, Section 15303(d), Class 4, Section 15304(b) and Class 11, Section 15311(a).

Projects exempted under Class 1, Section 15301(c) consist of the operation, repair or minor alteration to existing highways and streets, sidewalks, bicycle and pedestrian trails, and similar facilities. Projects exempted under Class 2, Section 15302(c) consist of the replacement of existing utility systems and/or facilities involving negligible or no expansion of capacity. Projects exempted under Class 3, Section number 15303(d) consist of new construction of small structures including street improvements. Project exempted under Class 4, Section number 15304(b) consist of new gardening or landscaping. Projects exempted under Class 11, Section 15311(a) consist of the construction or replacement of minor structures accessory to existing facilities including but not limited to on-premise signs.

This project is also subject to NEPA (National Environmental Protection Act). Pursuant to Chapter 3 of Title 23, United States Code, Section 320 and a Memorandum of Understanding (MOU) dated June 7, 2007, executed between FHWA and the State, the State determined that the project is a Categorical Exclusion under: 23 CFR 771 activity (c) (7.8.15), 23 CFR 771 activity (d).

Sustainability Considerations: This project is consistent with the City's Sustainability Master Plan. It conforms to the Air Quality Focus Area by improving and optimizing transportation infrastructure.

Other: None.

Commission/Committee Action: None.


Rationale for Recommendation: Martin General Engineering is the lowest responsive and responsible bidder.


Financial Considerations: The Broadway and Martin Luther King Jr. Boulevard Intersection Improvements Project (T15036100) has a total budget of \$2,142,645 consisting of SHRA Community Development Block Grant Funds (Fund 3701), Federal Capital Grant Funds (Fund 3703), and other Capital Grants Funds (Funds 3704). As of February 10, 2010, the unobligated balance is \$1,700,103, which is sufficient to execute the contract with Martin General Engineering in the amount of \$670,746 and cover construction management costs.

There are no general funds planned or allocated for this project.

The approval of this project will support 19 jobs in the City of Sacramento based upon the model provided by the Federal Highway Administration (FHWA) of one new job for every \$35,000 of transportation project investment.

Disadvantaged Business Enterprise (DBE): The Broadway and Martin Luther King Jr. Boulevard Intersection Improvements Project (T15036100) has federal funding and requires conformance with project participation guidelines for Disadvantaged Business Enterprise (DBE) /Underutilized Disadvantaged Business Enterprises (UDBE) in lieu of the City of Sacramento Emerging and Small Business Enterprise (ESBE) program requirements. The UDBE goal is 17.2%. If the Contractor does not meet the UDBE goal, Good Faith Effort toward meeting the required goal must be demonstrated. Martin General Engineering attained 67.2% UDBE participation and satisfactorily met the UDBE project goal.



Background Information:

The project will improve pedestrian access and safety and relieve traffic congestion and consists of removing and replacing existing curb, gutter, and sidewalk on Broadway, widening Broadway at the intersection of Martin Luther King Jr. Boulevard, upgrading ADA ramps, and modifying the traffic signal at the intersection of Broadway and Martin Luther King Jr. Boulevard.

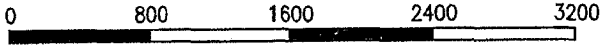
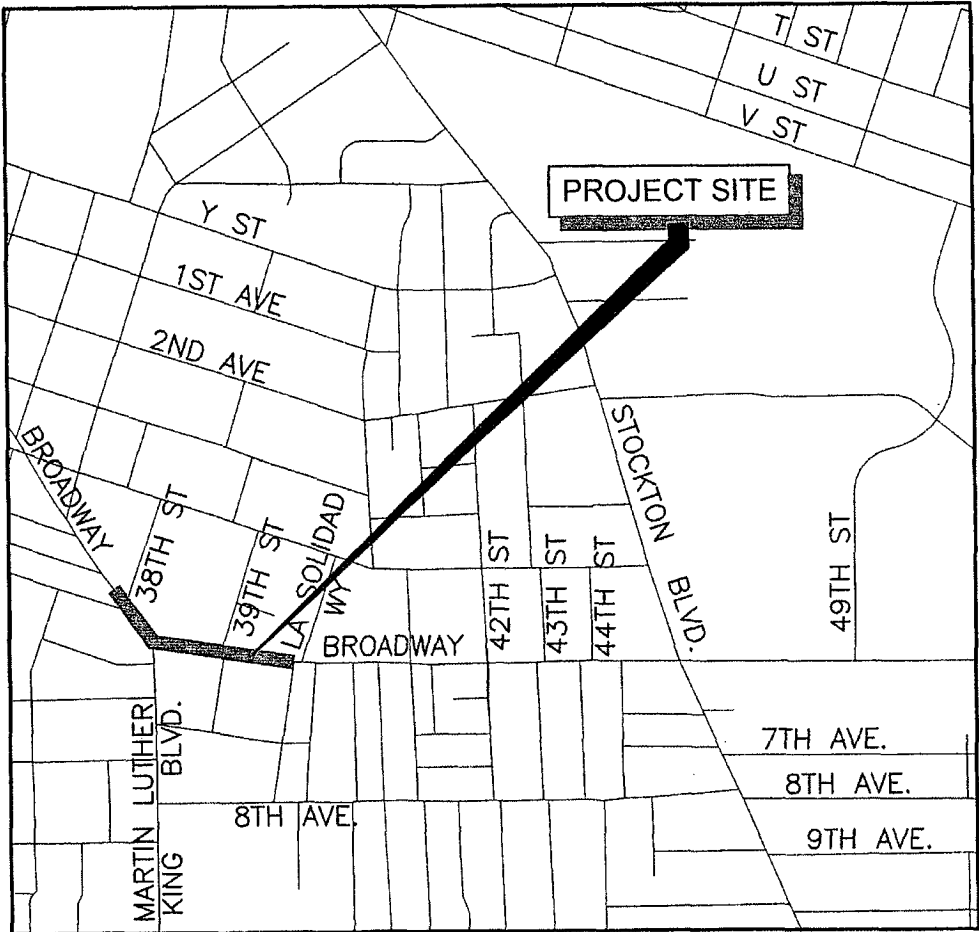
- Section 1. Plans and Specifications for the Broadway and Martin Luther King Jr. Boulevard Intersection Improvements Project (T15036100) are approved.
