SUBJECT: Time Limit Parking Regulation update, repealing Resolution 77-498.

SUMMARY

This report recommends the addition of a two hour limit on J Street between 36th and 39th Streets, and the east side of Royal Oaks Drive from Southgate Road to 200 feet south, and an update of various locations to the Time Limit Parking Resolution.

BACKGROUND INFORMATION

On May 4, 1981, the Mercy Area Residential Permit Parking Program was implemented and because of the possible impact of all day parkers fronting the addresses on J Street, the merchants submitted a petition for two hour limit parking. A survey and study of on-street parking conditions in the area was conducted and based on these results it was determined that the area is eligible for two hour limits.

Since the construction of two major buildings in Royal Oaks Drive area, parking on street has become minimal. The Royal Oaks Post Office requested a two hour time limit zone fronting the post office to accommodate customer service. We conducted a study of the area and recommend implementing a two hour restriction.

A survey and study was made of areas not included in this resolution, and based on the results of that study we are submitting an update to include those locations to the Time Limit Parking Regulations showing the new locations underlined and omissions lined out.

A RESOLUTION REGULATING PARKING TIME LIMITS

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

SECTION 1.

Pursuant to Section 25.109 of the Sacramento Code when signs are erected giving notice thereof, no person shall stop, stand, or park any vehicle upon any of the following descirbed streets or parts of streets for a period of time longer than indicated on the signs.

24 minute zones between 8:00 AM and 6:00 PM

5th Avenue, between 35th Street and 36th Street

11th Avenue, between Freeport Boulevard and 22nd Street

21st Street, between Larken Way and 1st Avenue
