

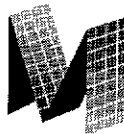

As directed by **Sacramento Recycling and Transfer Station**, MatriScope, Inc. was present at the above project on the dates shown to provide inspections of the work in progress as follows:

01/28/02 – Monday

Field Welding / Anchor Bolt Pull Testing

Report #5153

I arrived at the project site to observe field welding procedures for 3/16" welds of beams to 6" columns of tank canopy. They were found to be in accordance with plans, specifications for field welds condition X1.17 and AWS D1.1, complete. Also conducted pull test of 3/4" anchor bolts 6" embedment for tank plates. A total of eight bolts, 10% were tested, total of 2, with no failures. Bolts were pulled to 3500psi actual load 9570 pounds. Test results are in accordance with ICBO requirements utilizing pump #10024, Ram# 10274 and gauge 20042, 15 KIP.
