# Sacramento, California, May 3, 1929.

The Civil Service Board of the City of Sacramento met in special session on the above date at 6:40 o'clock P.M. in their office, Room 106 City Hall, President Chenu presiding:

PRESENT: Commissioners Mason, Weisman, and Chenu. ABSENT: None.

The minutes of the special meeting of April 25th were read and approved as read.

Affidavit was filed with the Board by H. E. Jones, Foreman of the Garbage Department, and E. Young, Garbageman, stating that E. Young had been reported as resigned from the Garbage Department on September 26, 1927, when in reality report should have shown leave of absence. In view of this statement of fact, and upon request of the Foreman of the Garbage Department, the Board, upon motion by Commissioner Weisman, seconded by Commissioner Mason, and unanimously carried, instructed the Secretary to correct the personal record of E. Young to read "Leave of absence from September 26, 1927, until December 28, 1927," instead of "Resignation" as shown on report No. 3082.

Communication was received from Baylies C. Clark, City Engineer, thanking the Board for reclassification of Rose C. Silveria, Permanent Street Improvement Clerk, from Junior Clerk to Stenographer.

Affidavit was presented by J. A. Sayers, Rodman in the Engineering Department, in which he claimed to have requested leave of absence as of May 14, 1919, whereas the record shows a resignation as of that date. Upon reading of this affidavit, the Board, upon motion by Commissioner Weisman, seconded by Commissioner Mason, and unanimously carried, instructed the Secretary to correct the record of Mr. Sayers to read "Leave of absence, May 14, 1919," instead of "Resignation" as now shown.

Upon motion by Commissioner Mason, seconded by Commissioner Weisman, and unanimously carried, the Secretary was instructed to draw up form for showing leave of absence and any other forms found necessary for the proper keeping of records of this department, same to be presented to the Board for its approval at the next meeting.

The Board then proceeded to review the examination papers for Store-keeper and Auto Mechanic.

Upon request, F. N. Evans, Superintendent of the Park Department, appeared before the Board relative to the recent employment of H. W. Culbertson. This man was formerly employed by the City as General Mechanic in the Park Department, from which position he resigned January 28, January 4, 1929, he made application for reinstatement and upon the recommendation of Mr. Evans, we submitted his request to the City Attorney for opinion as to legality of reinstatement. Mr. Bradford advised, under date of January 14, 1929, that he could not be reinstated. It appears that Mr. Evans had consulted with the City Manager relative to hiring Mr. Culbertson for swing crew work. The Chairman of the Board advised Mr. Evans that he was to make no appointments when eligible lists were established except from said eligible list, and that by the regular procedure; namely, the request to this Board for men as needed. Chairman also explained that upon proper requisition the three names highest on the eligible register would be certified to him, from which he could make his choice for appointment. The Chairman also advised Mr. Evans that since Mr. Culbertson had not been employed regularly, he could not be paid for services rendered inasmuch as this Board could not approve the pay roll.

The Board then proceeded to open the envelopes and establish identification of candidates having taken the examination for Storekeeper and Auto Mechanic. All candidates for the Storekeeper's examination failed.

The final percent in the Auto Mechanic examination equals the sum of the percent obtained in the written test, plus the percent obtained in the Personal Fitness test, divided by two. The date for the Personal Fitness test for Auto Mechanic was set for 6:30 O'clock P.M. May 16, 1929.

The Secretary explained that in establishing recent eligible lists, it had frequently occurred that two or more candidates received the same grade. In cases of this kind, candidate who filed his application first was given preference. The date of the certification of application by the City Clerk was the date used.

The Board then proceeded with the administration of Personal Fitness tests as follows:

- 7 applicants were interviewed for Oilers.
- 14 applicants were interviewed for Watchman.
- 3 applicants were interviewed for Deputy Assessor.

Willie Thompson, successful candidate for Garbageman in examination conducted by this Board on March 27, 1929, appeared before the Board and presented an honorable discharge from the United States Army which he neglected to present when he appeared for the Personal Fitness test. The Secretary was instructed to change this man's position on the eligible list giving him exservice mens preference.

William E. Morgan, successful candidate in the Janitors examination held by this Board on April 26, 1929, advised the Board that he was an exservice man. Mr. Morgan, however, did not have his discharge papers with him and was advised to present them at this office at his earliest convenience. The Secretary was instructed to change Mr. Morgan's position on the eligible list for Janitors, giving him exservice mens preference upon presentation of discharge papers.

Upon motion by Commissioner Weisman, seconded by Commissioner

Mason, and unanimously carried, eligible lists for the following classifications were established, effective June 1, 1929, and to be posted May 4, 1929:
