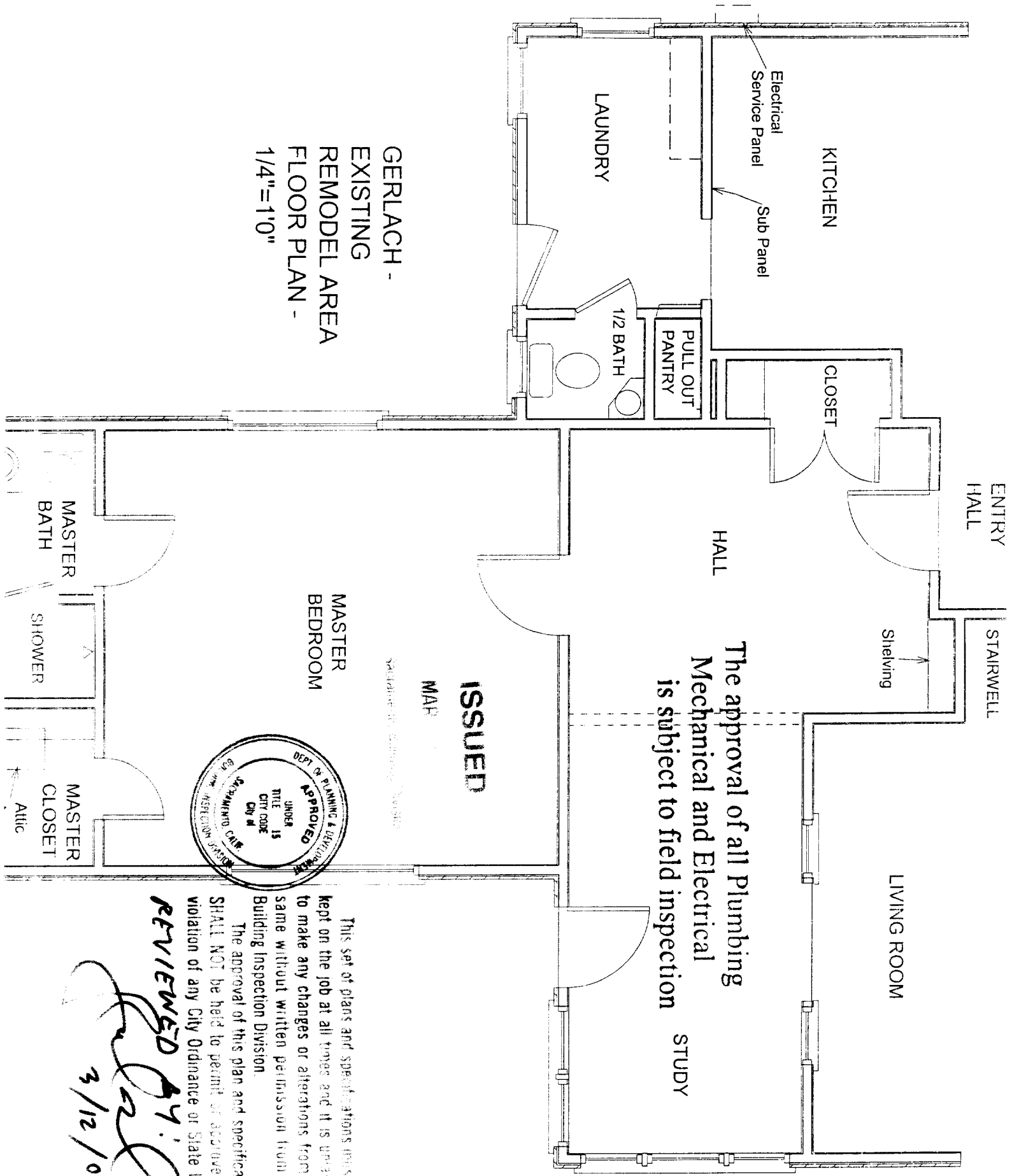

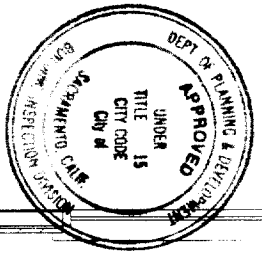
GERLACH -

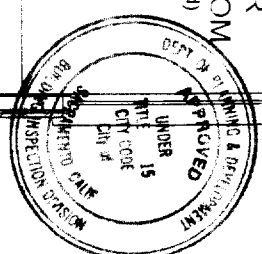
