RESOLUTION FIXING A HEARING DATE TO DETERMINE THE COSTS FOR THE ABATEMENT OF PUBLIC NUISANCES

WHEREAS, pursuant to the provisions of Chapter 61 of the Sacramento City Code (Nuisance Code), an authorized City of Sacramento Department Head or the Health Officer of the County of Sacramento instituted proceedings upon the properties described below; and

WHEREAS, the owners of the properties have consented to the abatement of the public nuisances; or a duly appointed City Hearing Examiner has, after public hearing, ordered the abatement of said public nuisances; and

WHEREAS, the City Council, pursuant to the provisions of the Nuisance Code, authorized the calling for bids and letting of contracts for the abatement of the public nuisances; and

WHEREAS, said work was performed by the contractors of the City for the following amounts, and the following administrative costs were incurred by the City:

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

That the City Council hold a hearing before it on November 25, 1980 at 7:30 p.m., in the City Council Chamber, 915 I Street, Sacramento, California, to determine the correctness of the costs of the abatement of the public nuisances as provided in Chapter 61 of the Sacramento City Code.

That after the correct costs for the abatement of said public nuisances have been determined by the City Council, said costs be made liens upon the properties involved, payable with regular City taxes.

That a notice of this hearing shall be posted on the properties described above, and shall also be sent to the owners of said properties in accordance with the provisions of Chapter 61 of the Sacramento City Code.
