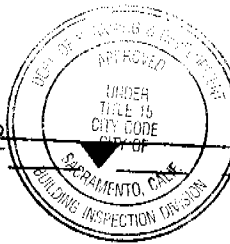

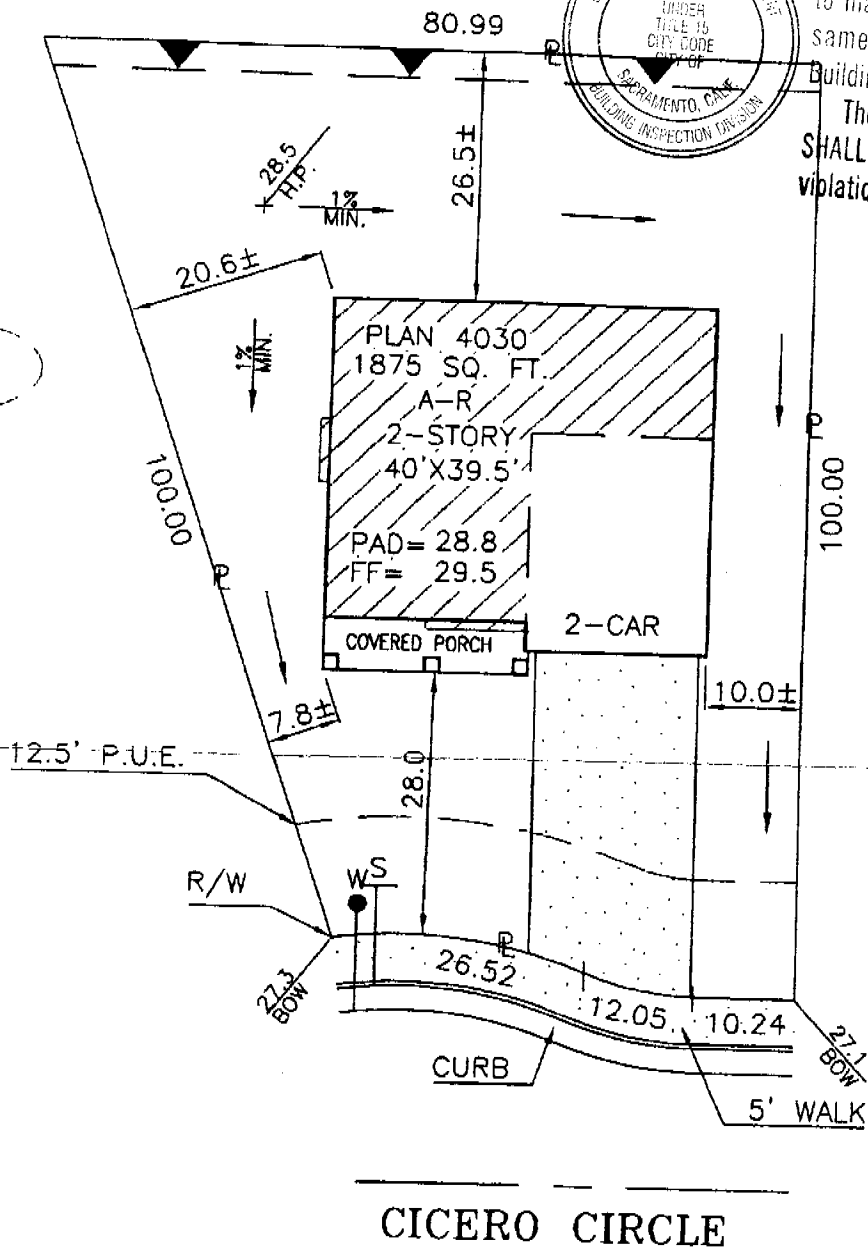
PLOT PLAN

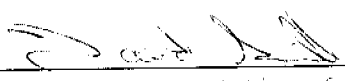
