Commissioners Absent:

- 1. The August 6, 1985 meeting was called to order at 4:10 p.m. with a physimance by Bob and Bonna wrenn New Works recipients.
- 2. The minutes of the July 2, 1985 meeting were approved.
- 3. Chair Report (Borden):
 - A. The City Council and County Board of Supervisors have decided not to expand the Commission; appointments are expected late September. The mayors of Isleton and Galt were contacted and are satisfied with the current structure. The Chair, director and Laurie Smith will meet with the mayor of Folsom next week. The Advocacy Committee will continue to lobby for expansion.
 - B. Committee Chair Appointments: Art In Public Places Laurie Smith; Program Dennis Wilkerson; Advocacy John Horrell; Cultural Awards Judy Gordon.
 - C. Cultural Amenities: Representatives from the Commission, City and County planning departments, and developers met to identify major issues concerning cultural amenities in Sacramento. Developers will be urged to attend future meetings.
 - D. Multicultural Programming (re: proposal submitted to CAC): After meeting with directors of major arts organizations to discuss how their multicultural programming could be increased, the staff recommended that SMAC focus on audience development for minority arts groups. The Commission will be notified of any amendment to the proposal.
- 4. Director's Report (Ceccherelli):
 - A. The Commission's Annual Report was distributed.
 - B. A series of workshops, sponsored by the CAC and co-hosted by SMAC will be held November 16, 1985, February 7, and April 3-4, 1986. Commissioners are urged to attend fundraising and board development workshops designed specifically for State Local Partners.
 - C. The Regional Arts Conference, co-sponsored by the CAC and NALAA will be held January 23-24, 1985.

5. Action Items:

- A. Advocacy (Tsuruda): A motion was made for SMAC to send letters of support to Assemblyman Sam Farr, author of AB 2092 and AB 2093 Arts in Education bills, and to Assemblymen Isenberg, Connelly, Duffy, Senators Green, Doolittle and Garamendi (moved Perham; second Rible). The motion was approved.
- B. APP (Johnson): A motion was made for SMAC to commission Colleen Barry-Wilson to fabricate a site-specific fiber artwork for the County Recorder's Office (moved Johnson; second Rible). The motion was approved.
- C. APP (Johnson): A motion was made for SMAC to approve Wynne Hayakawa as artist for the 23rd Street Station, Light Rail Art Program (moved - Johnson; second -Horrell; opposed - Tsuruda, Perham; abstaining -Neagle). The motion was approved.
- Cultural Awards (Rible): A motion was made for SMAC to D. the 1985/86 Cultural Awards panel: Claire approve Sacramento Symphony; Karen Schmidt, Harmony Schweikert, CSUS Theatre Department: Michael Gates, Commissioners Gordon and Wilkerson; alternates Jacqueline Sheridan, Sunny Smith and D. R: - Rible; second - Neagle). The motion was (moved approved.
- D. New Works (Gordon): A motion was made for SMAC to approve the New Works panel (round two): Theresa Vinciguerra, Poet Tree; Olivia Castellano, CSUS, English Department; C. B. Davis; Commissioners Gordon and Wilkerson; alternates Jeff Cloud and Ariel Tomioka (moved Gordon; second Tsuruda; opposed Borden, Horrell, Johnson, Neagle, Perham, Rible, Tsuruda). > A motion was made for SMAC to select one panelist from the recommended list in addition to two commissioners to serve on the New Works panel (round two) (moved -Johnson; second - Perham). The motion was approved.

E. Advocacy: A motion was made that the Commissioners Handbook state that the new Chair take office August 1 (moved - Borden; second - Tsuruda). The motion was approved.

6. Committee Reports:

- A. Executive (Borden): A motion was made for SMAC to approve the Committee's recommendation to 1) let the present language of the APP Ordinance stand, and 2) request the Commission to form a committee of three commissioners and four members of the performing arts community to assess the needs of the performing arts community (moved Tsuruda; second Neagle; opposed Rible). The motion was approved.
- B. Advocacy (Tsuruda): A report on the description and charges of the committee will be presented to the Commission in September.
- C. APP (Johnson): The committee met to discuss the Old Sacramento Gateway Project.
- D. Cultural Awards (Rible): Christopher Watson has assumed the duties of coordinator of the Cultural Awards program. The committee has been considering two issues: 1) a policy on comp tickets to commissioners and panelists, and 2) evaluation methods. Johnson recommended that not less than 75% of an applicant's request be granted. Horrell asked if the SMAC office could reimburse commissioners for the cost of tickets.

The Board of Supervisors will consider the Cultural Awards budget Friday, August 9, 9:30 p.m. 1984/85 recipients have been notified of the hearing.

E. Program:

- 1. New Works (Gordon): After evaluating the first round of New Works, the committee recommended that applicants be notified in writing of panel's recommendation before the Commission meets. The New Works round two schedule is: August 26 panel to meet; September 10 panel recommendations to Commission; September 13 contracts sent to awardees. Johnson recommended that grantees of this pilot project be awarded 100% of their request and not be eligible for further New Works grants for three years.
- 2. Arts In Education (Wilkerson): Wilkerson reported the following list of priorities of the AIE task force:

- a) Foster and provide AIE and resources for all students.
- b) Provide a network for all districts to share and develope quality AIE programs.
- c) Coordinate existing and new AIE activities for county.
- d) Secure funding and services for the implementation of AIE in the city of Sacramento.
- e) Link community AIE resources in the county.
- f) Promote AIE outreach to the community at large.
- 7. Old Business: None.
- 8. New Business: Bob and Donna Wrenn performed some of their New Works compositions.

Tsuruda suggested the Commission consider a fundraiser similar to the one presented by the San Francisco Arts Commission.

B. L. Kennedy, New Works recipient stated that another recipient used his copyrighted material without permission. SMAC staff will look into the matter.

The September 10 Commission meeting will be held at Rhoades School, Elk Grove Park, Elk Grove at 4:00 p.m. Following the meeting a buffet dinner will be held hosted by the Elk Grove Chamber of Commerce. A free concert in Elk Grove Park will be presented by the Sacramento Symphony at 8:00 p.m.
