**SUBJECT: 2<sup>nd</sup> AVENUE REALIGNMENT AND TRAFFIC SIGNAL PROJECT (PN: TA21)-  
APPROVAL OF PLANS AND SPECIFICATIONS, APPROVAL OF FUNDING AND  
COOPERATIVE AGREEMENT WITH THE UNIVERSITY OF CALIFORNIA  
REGENTS, APPROPRIATION OF FUNDS AND CONTRACT AWARD**

**LOCATION AND COUNCIL DISTRICT:**

2<sup>nd</sup> Avenue between Stockton Boulevard and 45<sup>th</sup> Street. Council District 5.

**RECOMMENDATION:**

This report recommends that the City Council:

- Approve the plans and specifications;
- Adopt the resolution which approves a Funding and Cooperative Agreement with the University of California Regents to cover the costs of the 2<sup>nd</sup> Avenue Realignment and Traffic Signal Project;
- Adopt the resolution which appropriates funds in the amount of \$734,262.32 per the Funding and Cooperative Agreement with the University of California Regents;
- Appropriates City Water and Drainage funds which total \$255,316;
- Accept the low bid from Biondi Paving in the amount of \$915,958.70;
- Authorize the City Manager to execute a contract for the 2<sup>nd</sup> Avenue Realignment and Traffic Signal Project.

**SUMMARY:**

Bids were received on February 4, 1998. Biondi Paving submitted one bid in the amount of \$915,958.70. This bid was less than Biondi Paving's low bid of \$944,497.15 and Teichert Construction's bid of \$1,047,646.40 submitted on August 20, 1997, which were rejected.

The 2<sup>nd</sup> Avenue Realignment and Traffic Signal Project will extend 2<sup>nd</sup> Avenue east of Stockton Boulevard and construct a traffic signal at the intersection. Other improvements include landscaping of 2<sup>nd</sup> Avenue and water/drainage improvements.

The University of California Regents have agreed to fund the cost of the project except for additional water and drainage works requested by the Department of Utilities and the cost of inspection which will be covered by City funds.

**COMMITTEE/COMMISSION ACTION:** None.

**BACKGROUND INFORMATION:**

The project was advertised and bids were received on February 4, 1998.

Biondi Paving was the sole bidder at \$915,958.70. Their MBE/WBE participation is 44.15% and 25.91% respectively, which meets the City's goals.

The Engineer's Estimate was \$680,000.

The University of California Regents, who are paying the majority of the project costs, recommend contract award.

Approval of the plans and specifications and award to Biondi Paving for the lowest responsive/responsible bid is recommended.

**FINANCIAL CONSIDERATIONS:**

The estimated total project cost is \$1,035,000. The existing project budget is \$46,000. Additional appropriations in the amount of \$989,578 are sufficient to cover the total project costs.

**ENVIRONMENTAL CONSIDERATIONS:**

A Negative Declaration has been approved for this project.


**POLICY CONSIDERATIONS:**

**MBE/WBE EFFORTS:**



The project was also announced on the Project Information Line and on the City's Internet site at [www.sacto.org/bids](http://www.sacto.org/bids). Project notices were sent to 30 organizations involved in MBE/WBE recruitment.



**RESOLUTION APPROVING AN AGREEMENT WITH THE UNIVERSITY OF CALIFORNIA  
REGENTS AND APPROPRIATION OF FUNDS FOR THE 2<sup>ND</sup> AVENUE REALIGNMENT AND  
TRAFFIC SIGNAL PROJECT (PN: TA21)**

**BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF SACRAMENTO:**

1. That the City Manager is authorized to execute the agreement with the University of California Regents in an amount of \$734,262 to cover the costs of the project.
2. That the 1997/98-revenue budget be increased by \$734,262 to reflect the University of California Regents contribution toward the project.
3. That \$734,262 is appropriated to the project (248-500-TA21-4820).
4. That \$63,316 in Water Funds be transferred from the Base CIP Reserve-Water Fund (413-500-ZE46-4414) to the project (413-500-TA21-4820).
5. That \$192,000 in Combined Sewer Funds be transferred from the Combined Sewer System Reserve Fund to the project (TA21) as follows:
