RESOLUTION EXTENDING TIME NO. 2733


ADOPTED BY THE SACRAMENTO CITY COUNCIL

November 18th, 1949

RESOLVED by the City Council of the City of Sacramento, that the Superintendent of Streets of the City of Sacramento, be, and the same is hereby directed to grant the following extension of time on Contract for the performance of street work; provided, that in no event shall any liability accrue by reason thereof to the City of Sacramento, or to the said Superintendent of Streets, to-wit:
