**RECOMMENDATION:**

This report recommends that the City Council:

- Approve the plans and specifications for the 13th Street Sewer Main Replacement between L Street to S Street project.
- Authorize the City Clerk to advertise for bids to be received on June 29, 1994.

**SUMMARY:**

This project will remove the existing 24" combination sewer main, maintenance holes, drain inlets, drain leads, and related appurtenances between L and S Street and replace the system with a new 30" combination sewer main and related appurtenances. An existing deteriorated 18" sewer main will be abandoned in place. Numerous other drain leads and smaller feeder lines will also be replaced along 13th Street.

The State of California has entered into an agreement with the City of Sacramento to reconstruct 13th Street through Capitol Park (L to N Streets) in conjunction with the sewer main reconstruction project. This reconstruction will consist of the removal and replacement of the existing pavement and base section curb and gutter.

The sewer main improvements, which include the removal and replacement of the existing pavement and base sections of curb and gutters will provide neighborhood enhancement and revitalization and increased public safety. The MBE/WBE program goals included in the project promote City-wide inclusiveness of our diverse population.

Plans and specifications for the 13th Street Sewer Main Replacement between L and S Street project have been prepared. Approval of the plans and specifications and authorization to advertise for bids is recommended.

**COMMITTEE/COMMISSION ACTION:** None.

**BACKGROUND INFORMATION:**

This project will remove the existing 24" combination sewer main, maintenance holes, drain inlets, drain leads, and related appurtenances between L and S Street and replace the system with a new 30" combination sewer main and related appurtenances. place. Numerous other drain leads and smaller feeder lines will also be replaced along 13th Street.

The State of California has entered into an agreement with the City of Sacramento (Agreement No. 93-110) to reconstruct 13th Street through Capitol Park (L to N Streets) in conjunction with the sewer main reconstruction project. This reconstruction will consist of the removal and replacement of the existing pavement and base section curb and gutter.

A Categorical Exemption for the 13th Street Sewer Replacement between L and S Street project was filed with the County Recorder of the County of Sacramento on December 17, 1990.

**FINANCIAL CONSIDERATIONS:**

The engineer's estimated construction cost is \$630,000.

The estimated total project cost, including all planning, design and construction costs, is \$834,000. The current budget is \$168,400, which was approved in the 1992/93 Capital Improvement Program from the Sewer Fund (414). The funds available for this project amount to \$109,405, as of May 12, 1994.

An estimated additional \$665,500 will be needed for this project. Recommendations for additional funding will be made after receipt of bids. Proposed sources for additional funding are listed below:

A non-refundable fee of \$25 will be charged for each set of plans and specifications to cover reproduction costs.

**POLICY CONSIDERATIONS:**

The subject project promotes City Council priorities regarding neighborhood revitalization and enhancement and public safety.

This action is consistent with Title 58, Chapter 58.03.301 of the City Code concerning advertisement for bids and Resolution No. 93-619 relating to MBE/WBE participation goals and policies adopted by the City Council on November 2, 1993.

**MBE/WBE:**

This project will include MBE/WBE participation goals of 10.57% MBE and 9.5% WBE as required by Resolution No. 93-619 relating to MBE/WBE participation goals and policies adopted by the City Council on November 2, 1993. Award of contract will be contingent upon the responsive low bidder either meeting the project MBE/WBE participation goals or making adequate Good Faith Efforts towards meeting the project goals. Bids submitted which meet or exceed the MBE/WBE goals may be eligible for bid price preferences up to a maximum of 7% or \$25,000, whichever is lower.

Plans and specifications will be sent to seven (7) plan rooms and construction services organizations for publication and use by the construction industry of Northern California. There are four (4) organizations on the distribution list that are directly involved with outreach to MBE/WBE contractors.


Other outreach efforts to MBE/WBEs for this project will include:

- Advertisement of the project on the City of Sacramento Construction Project Bid Line (916) 392-4758.
- Free access to review the project plans and specifications at the City of Sacramento Planroom at Engineering Division offices at 927 10th Street.

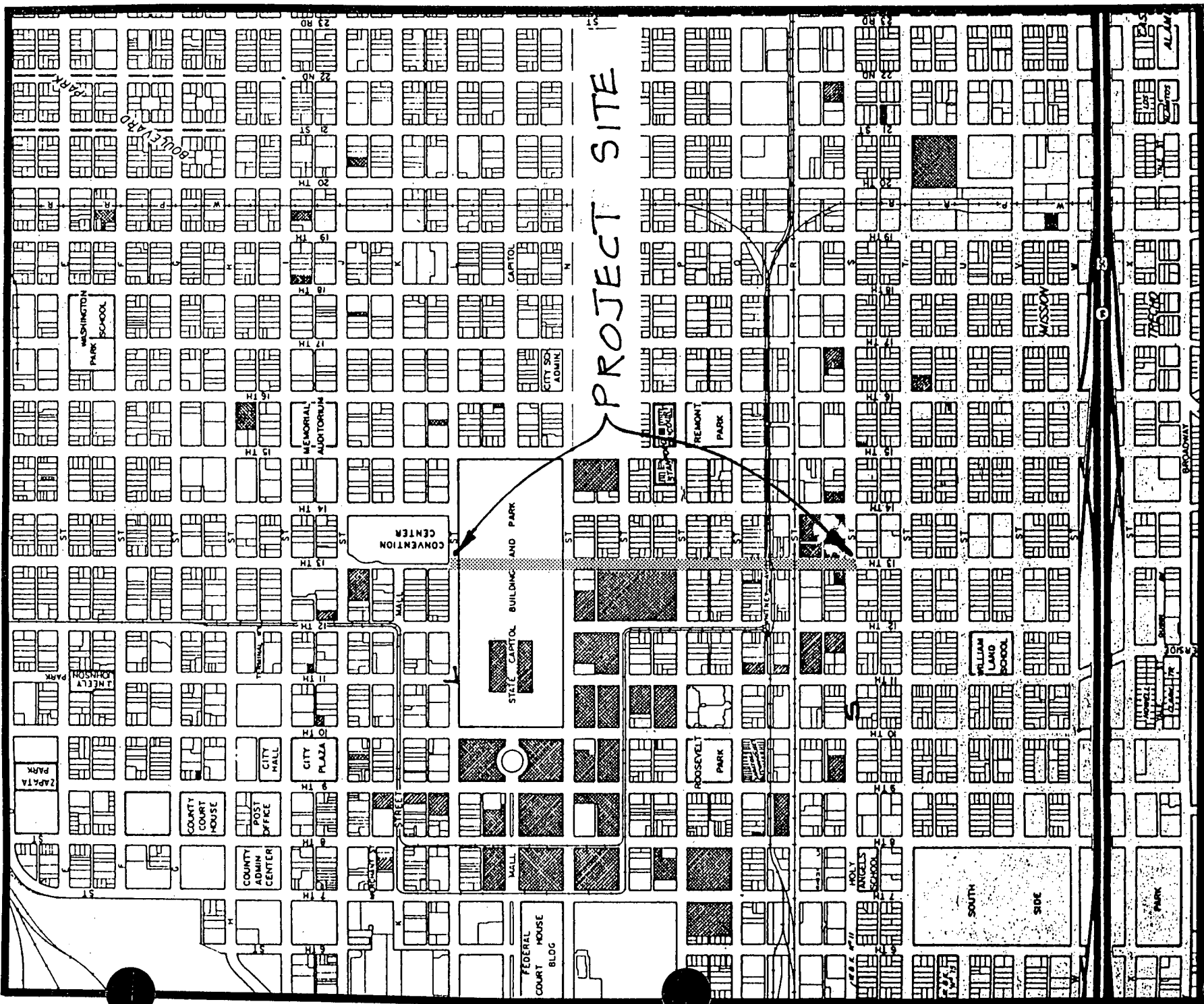
