SUBJECT: AN ORDINANCE AMENDING THE CITY CODE, SECTION 19.427(c) - LAWN AND GARDEN REFUSE TAX CLASSIFICATION BOARD

SUMMARY

This report recommends the adoption of an ordinance which would amend City Code, Section 19.427(c) - Lawn and Garden Refuse Tax Classification Board, by changing the language as it pertains to the membership of the board.

BACKGROUND

The Lawn and Garden Refuse Tax Classification Board is composed of two members, a representative from the Department of Finance and a representative from the Department of Engineering (Public Works), Division of Waste Removal (Solid Waste). Its purpose is to process all applications and make the classifications of property described by Section 19.427.

At the time City Code Section 19.427 was adopted, garden refuse collection was handled by the Division of Waste Removal. The Waste Removal Division Manager has been appointed to the board by the City Manager in the past.

On July 1, 1988, the street maintenance section of the Transportation Division merged with the garden refuse and street sweeping functions of the Solid Waste Division to form the new Street Division. Now that garden refuse collection is a function of the Street Division, it is appropriate that the City Manager have the option of appointing the Street Division Manager to serve on the board. Therefore staff is recommending that the obsolete reference to the "Department of Engineering, Division of Waste Removal" be replaced with the "Department of Public Works." (See Attachment A)

FINANCIAL

There are no financial implications in changing the language of section 19.427(c).
