RECOMMENDED DECISION OF ADMINISTRATIVE LAW JUDGE - ANTHONY CRESPO

Mr. Antoine requested that the Board modify the proposed decision of the Administrative Law Judge to include the discipline initially imposed by the Department to reduce Lieutenant Kane's salary from Step E to Step C but not to include the 80-hour suspension without pay or the letter of reprimand.

Mr. Richard Chiurazzi, Attorney at Law, representing Lieutenant Kane addressed the Board. Mr. Chiurazzi informed the Board that Lieutenant Kane was present and wished to address the Board. Lieutenant Kane addressed the Board and asked them to reduce the recommended discipline of the administrative law judge to letter of reprimand.

The motion was approved by unanimous roll call vote.


