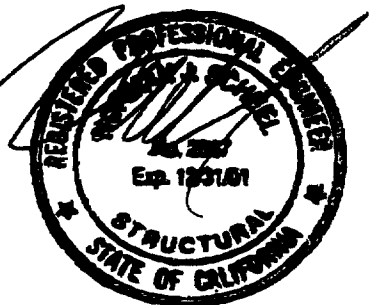

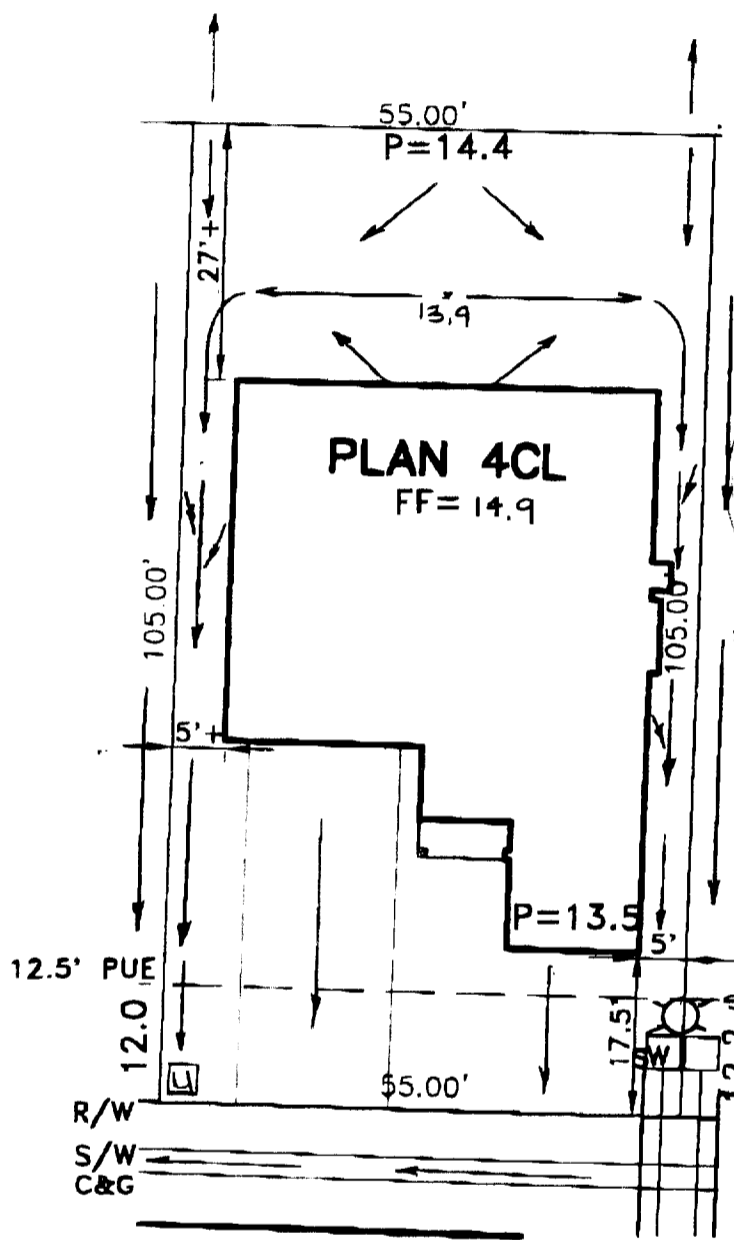
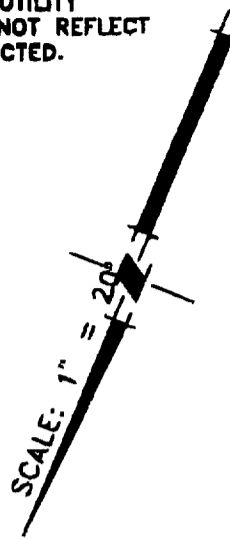
1. 4x12 header over service panel in garage Plan 3: This is to clarify that the 4x12 with single trimmers in one stud bay are adequate to support the girder loads and transfer them to the foundation.
2. Notch in 4x6 post: This is to clarify that a 1 1/4" x 2" notch in the 5 1/2" face of the 4x6 is OK. With a net post area of 3 1/2" x 4 1/4", the loads from beam #2 are still within the compressive strength of the post.
