Subject: Metropolitan Arts Division - Appropriation Increase for Public Arts Catalogue

SUMMARY

This report recommends a \$2,585 increase to the FY 1979-80 budget of the Metropolitan Arts Division to reflect funds donated by Citizen's Savings & Loan.

BACKGROUND

Citizen's Savings & Loan held a fundraiser in June of 1979 to benefit the Sacramento Metropolitan Arts Commission. The gift, in the amount of \$2,585, was provided to improve the services of the Metropolitan Arts Commission. The Commission and staff feel that the donation can be most beneficial to produce a Public Arts Catalogue. The contents of the Catalogue is made possible through various sources of funds including CETA and a grant from the California Arts Council.

FINANCIAL DATA

There is no additional cost to the City.

RECOMMENDATION

It is recommended that the City Council, by resolution, increase appropriations to the Metropolitan Arts Division by \$2,585 for the purpose of printing and graphics design services for a Public Arts Catalogue.

RESOLUTION AMENDING THE CITY BUDGET FOR FY 1979-80
FOR THE DEPARTMENT OF COMMUNITY SERVICES
(Metropolitan Arts Division)

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF SACRAMENTO:

1. The receipt of monies raised through a fundraising benefit by Citizen's Savings and Loan requires an appropriation increase of \$2,585 for the budget of the Department of Community Services.
2. The City budget for FY 1979-80 is hereby amended:
 - a. By adding thereto the sum of \$2,585 to budget number 1-01-2281 relating to the expenditure of funds for a Public Arts Catalogue.
3. The above appropriation increase is to be supported by a \$2,585 donation that is forthcoming from the Citizen's Savings and Loan which will be deposited in the general fund.
