SUMMARY

The Department of General Services is resubmitting specifications for dredging services at the Sacramento Boat Harbor. Copy of the revised specifications has been forwarded to the City Clerk and approval is recommended.

BACKGROUND

The subject project is a periodic selective dredging of the entire harbor. This extensive dredging was last performed in 1977. On May 29, 1984, Council adopted specifications (Bid #649) which must be withdrawn due to changes in the scope of work.


FINANCIAL DATA

The estimated cost of \$95,000 for dredging is provided for in the FY 1983-84 Boat Harbor Budget.
