

*Bid totals represent costs for type of services, used for evaluation purposes only, and are not indicative of actual amounts to be expended in each category or group during the year. As actual usages for each grouping are difficult to pre-determine, Procurement Services requests that the total award be made in an amount not to exceed \$330,000.00, to be split among the eight (8) indicated firms as deemed appropriate. In order to insure adequate coverage of printing services within a time period acceptable to the needs of the City, three (3) firms were selected for each group/category and are ranked as (1) primary, (2) secondary and (3) back-up.
