

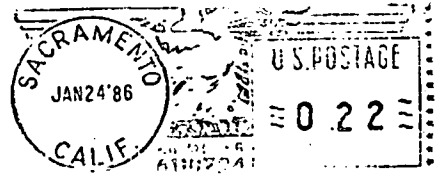

1. The height of the proposed office building shall not exceed six stories or 78 feet measured from grade level to the top of the plate line of the sixth floor (roof parapet may exceed 78 feet);
2. Building elevations and floor plans shall also be revised to include a retail element on the first floor of the building;
3. Revised elevations shall be subject to the review and approval of the Planning Director and the City Design Review/Preservation Board prior to issuance of building permits; and
4. The project shall comply with the mitigation measures of the Environmental Coordinator. In addition, the TSM Plan shall begin at 50% occupancy and the applicant shall show that the office project has achieved a minimum 20% peak hour traffic reduction for three consecutive years.
