

## RESOLUTION No. 1028

Adopted by The Sacramento City Council on date of

WHEREAS, a Regular Municipal Election was held in the City of Sacramento on the 7th day of November, 1939, pursuant to provisions of Article XXI of the City Charter of the City of Sacramento now in force, for the purpose of electing nine (9) members of the City Council of said city to serve for a term of two (2) years beginning January 1st, 1940 and ending December 31st, 1941; and

WHEREAS the vote and returns of said election have been canvassed by the City Council of the City of Sacramento convening as a canvassing board and the results duly ascertained;

NOW THEREFORE BE IT RESOLVED, DETERMINED AND DECLARED that the total number of ballots cast by electors at said election was 48,445.

THAT THE TOTAL number of City Councilmen to be elected was nine (9);

THAT THE FOLLOWING CANDIDATES being all of the candidates at said election, receiving the number of votes set opposite their respective names, to-wit:

AND BY REASON THEREOF were duly elected as Councilmen of the City of Sacramento for the aforesaid term;


