### Summary:

The Resolution (2001-041) authorizing the temporary closure of the subject alley has expired. With this expiration, the neighboring residents and property owners in Council District 5 request that the City re-close the subject alley for another period of 18 months. Staff recommends approval of this alley closure pursuant to Vehicle Code 21101.4 and Sacramento City Code 12.16.

Committee/Commission Action: None.

### **Background Information:**

On August 1994, the City Council approved the Resolution No. 95-536 temporarily closing the subject alley for 18 months. This temporary closure was not extended until January 2001. On January 16, 2001, Resolution 2001-041 was adopted by City Council

extending the temporary closure for an additional 18 month period. This Resolution extending the closure of the subject alley expired on July 2002. With this expiration, the majority of the adjacent property owners and residents to the alley requested that the City close the subject alley for another 18-month period.

From the date of the expiration of the extension of closure to March 2005 the alley remained closed. On March 22, 2005, the City locked-open the gates at this alley and began processing the request for re-closure. This re-opening of the alley and request for re-closure were prompted by the request of the owners of 4121-B 51st Street to relocate the gate located near San Francisco Blvd. This gate is currently located 15 feet south of San Francisco Blvd (or 15 feet from back of walk). The owners of 4121-B 51st Street requested this gate be relocated approximately 160 feet south of San Francisco Blvd (see Attachment "B"). This alley serves as main access for 4121-B 51st Street to a public street. The owners of 4121-B 51st Street have reported to the City that the current location of the gate is very inconvenient to them since their only access is off the alley. However, relocating this gate will expose 4 properties, namely 5110 & 5118 San Francisco Blvd, 4122 52nd Street and 4121-B 51st Street, to public access.

The owners of 5110 & 5118 San Francisco Blvd, and 4122 52<sup>nd</sup> Street do not support the relocation of the gate. They believe that their properties will be exposed to lawbreakers when the gate is relocated. During the period the gates were opened, one of these properties was burglarized. The owners told staff that during a police investigation, a police officer told them that most likely the burglar used the alley as an access point to their property. In addition, relocating the gate will also expose the northern portion of the alley to illegal dumping. Since the opening of the alley, owners and residents also reported other illegal activities occurring in the alley such as abandoned vehicles, prostitution, illegal parking, and illegal dumping. The Sacramento Police Department has reported that in the period from May 1, 2005 to August 31, 2005, the average call for Police service in the area of the subject alley is 1.65 calls per day with a total of 194 calls for Police service (see Attachment "C-1").

For the safety of the neighboring residents and property owners, staff recommends closure of the alley for another 18 month period and the gate remain in its current location. Property owners and residents who have access to the alley will be provided a key to access the gates. This closure will assist the prevention, or at least the reduction, of the occurrences of crime-related activities in the subject alley. Staff has determined that the requested closure of the subject alley meets the criteria set forth in the Vehicle Code 21101.4 and Sacramento City Code 12.16.

The Police Department recommends the implementation of the temporary closure of the subject alley. This closure will assist in preventing the occurrence or reoccurrence of crime related activities in the subject alley (see Attachment "C").

Verification has been obtained from the Fire Department that the proposed closure will not adversely impact their operation or safety in the surrounding neighborhoods (see Attachment "D").

Verification has been obtained from the Department of Transportation that proposed closure does not include a through highway or an arterial street. The alley closure allows adequate and safe traffic circulation on the adjacent streets (see Attachment "E").

The subject street closure is not to exceed eighteen (18) months unless the closure is properly extended. Once approved, the closure may be extended for an additional five (5) consecutive periods of not more than eighteen (18) months each. Prior to each extension, City Council must hold a public hearing.

Noticing to the public regarding the temporary closure has been completed prior to City Council meeting in accordance with City Code section 12.16.220.

### **Financial Considerations:**

This request is processed under the Problem Alley Abatement Program of the City. The program, which provides for the construction of gates and necessary signs on alleys with crime-related problems, was approved for FY 2005/2006 by City Council and will be funded by the approved Development Services Department, Development Engineering and Finance Division's FY 2005/2006 operating budget.

### **Environmental Considerations:**

The Environmental Planning Services Division of the Development Services Department has reviewed the temporary closure and determined that the activity is exempt from the provisions of the California Environmental Quality Act (CEQA) under Section 15301(f) of the CEQA Guidelines. This project consists of the temporary closure of an existing road by adding gates to the entrances of the alley. This temporary closure involves no expansion of use beyond what currently exists. Access to the road will be given to appropriate departments and agencies.

### **Policy Considerations:**

The temporary closure is in furtherance of Vehicle Code Section 21101.4 and Sacramento City Code Chapter 12.16 allowing the temporary closure through street or alley. This is consistent with the City's Strategic Plan 3 Year Goals in that it will improve and expand public safety, achieve sustainability and enhance livability. This is in keeping with the City's vision of being the most livable city in America.





### RESOLUTION APPROVING THE TEMPORARY CLOSURE OF THE ALLEY BOUNDED BY SAN FRANCISCO BOULEVARD, 52<sup>ND</sup> STREET, 20<sup>TH</sup> AVENUE, STOCKTON BOULEVARD AND 51<sup>ST</sup> STREET WITHIN COUNCIL DISTRICT 5

### TEMPORARY CLOSURE PROCEEDING NO. TSC05-05

### **BACKGROUND**

- A. The City received a request from the abutting property owners and residents to the subject alley to temporarily close the subject alley to stop the occurrences of crime related activities.
- B. The Vehicle Code of the State of California Section 21101.4 and the Sacramento City Code Chapter 12.16 authorizes the City Council to temporarily close streets and alleys to prevent occurrences of crime related activities.

### BASED ON THE FACTS SET FORTH IN THE BACKGROUND, THE CITY COUNCIL RESOLVES AS FOLLOWS:

- Section 1. Based upon substantial evidence present in the record of the proceedings regarding this matter, City Council hereby makes the following findings:
  - a. There are serious and continual criminal activity in the area of the alley recommended for closure. This finding is based upon a recommendation of the police department.
  - b. The alley recommended for closure is under the City's jurisdiction and has not been designated as a through highway or arterial street.
  - c. Vehicle or pedestrian traffic in the alley recommended alley closure contributes to the criminal activity that is occurring there.
  - d. The alley closure will not substantially adversely affect traffic flow, safety on the streets or in the surrounding neighborhoods, the operation of emergency vehicles, the performance of municipal or public utility services, or the delivery of freight by commercial vehicles in the area of the alley closure.
- Section 2. The Council finds and determines that the alley closure of the subject alley will substantially alleviate the existing serious and continual criminal activity in that street.

- Section 3. City Council grants this alley closure of the alley with the following conditions:
  - a. A gate security device approved by the Sacramento Fire Department will be installed on the gates.
  - b. City departments and utility companies will have twenty-four (24) hour access to their facilities within the road.
