*The Secretary informed the Board that Patrolman examination #1168-F was for Community Service Officers who had successfully passed all phases of the Patrolman test prior to their appointment as Community Service Officers in the fall of 1970. Therefore, this eligible register was established upon performance evaluation of each Community Service Officer by Police Chief Kinney.

CHANGES IN PREVAILING HOURLY CONSTRUCTION RATES - Machinist and Mechanics Lodge #2182

Listed below are construction rates as outlined in the agreement between the Construction Industries and the Machinist and Mechanics Lodge #2182, I.A.M.A.W. As the rate increases were in excess of the 5.5%, the legally permitted increase under the Federal Pay Board guidelines, it was moved by Mr. Street, seconded by Mr. Reynoso, and carried by unanimous vote to approve an adjustment in prevailing construction hourly rates to within the limits permitted by the Federal Pay Board, and to approve the further adjustment to the full rate contained in the agreement at such time as permitted by the Pay Board, as follows:

Communication from Mrs. Carnation Allen requesting six months' leave of absence from July 26, 1972, was considered. She plans to be married in July and to take an extended vacation. Her request had the approval of Police Chief Kinney and the City Manager.

Motion was made by Mr. Street, seconded by Mr. Reynoso, and carried by unanimous vote to grant Mrs. Allen's request for leave of absence for a period of six months.

RANDOM SELECTION OF CANDIDATES FOR MAINTENANCE MAN II (TRUCK DRIVER) WHO WILL BE INVITED TO THE ORAL INTERVIEW

The Secretary informed the Board that 217 applicants had passed the written examination for Maintenance Man II (Truck Driver). Of these, 25 are currently employed by the City and, therefore, would be invited to the oral interview. It was recommended that 36 persons be randomly selected out of the remaining 193

candidates, making a total of 61 candidates who will be interviewed for Maintenance Man II (Truck Driver).


It was moved by Mr. Reynoso, seconded by Mr. Street, and unanimously carried to approve the random selection procedure as recommended for the Maintenance Man II (Truck Driver) examination.

The random selection procedure was identical to that described in the minutes of November 30, 1971. The numbers selected have been circled on the attached list of candidates who had successfully passed the written test. Names of the 25 persons currently employed by the City and who will be invited to the oral interview are also on the attached list. The names of those who were not randomly selected will be held in reserve during the life of the list for future drawings, if additional names are needed, and for oral interviews.


FIRE DEPARTMENT PROMOTIONAL ORAL BOARD SELECTION GUIDELINES
