AMENDMENT OF CLASSIFICATION PLAN:

Secretary advised that a request was received from the Director of Recreation and Parks to amend the classification plan by adoption of

specifications for the proposed new class of Zoo Herpetologist with a recommended salary range of \$750 to \$900 per month. Proposed specification for this class was presented to the Board.

The Secretary advised that it was necessary to revise the specifications for the classes of Telephone Operator and Chief Telephone Operator because of the change-over to a new Centrex system. Proposed specifications for these classes were presented to the Board.



These new specifications were presented to the Board.

After reviewing the proposed specifications for these classes, the Board directed the Secretary to separate the single specification for Maintenance Man II and Maintenance Man II (Truck Driver) into separate specifications in order to more clearly define and separate the duties of the two classes.

It was the order of the Board that action to adopt the proposed specifications for the classes of Zoo Herpetologist, Telephone Operator and Chief Telephone Operator, and Maintenance Man II (Truck Driver) be scheduled for the next regular meeting in accordance with provisions of Section 4.5 of the rules and regulations.
