I will expedite necessary revisions, corrections and clarifications as required to obtain the building permit.

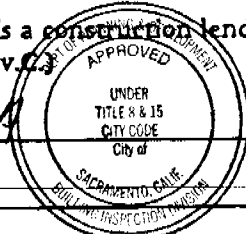
