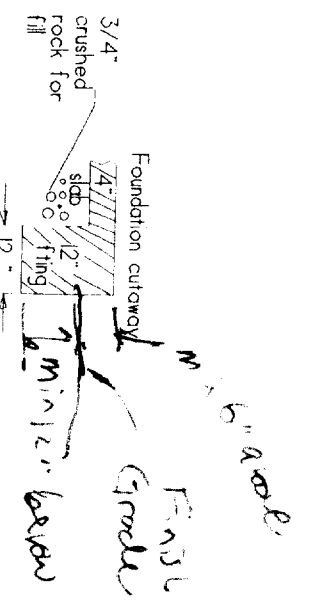

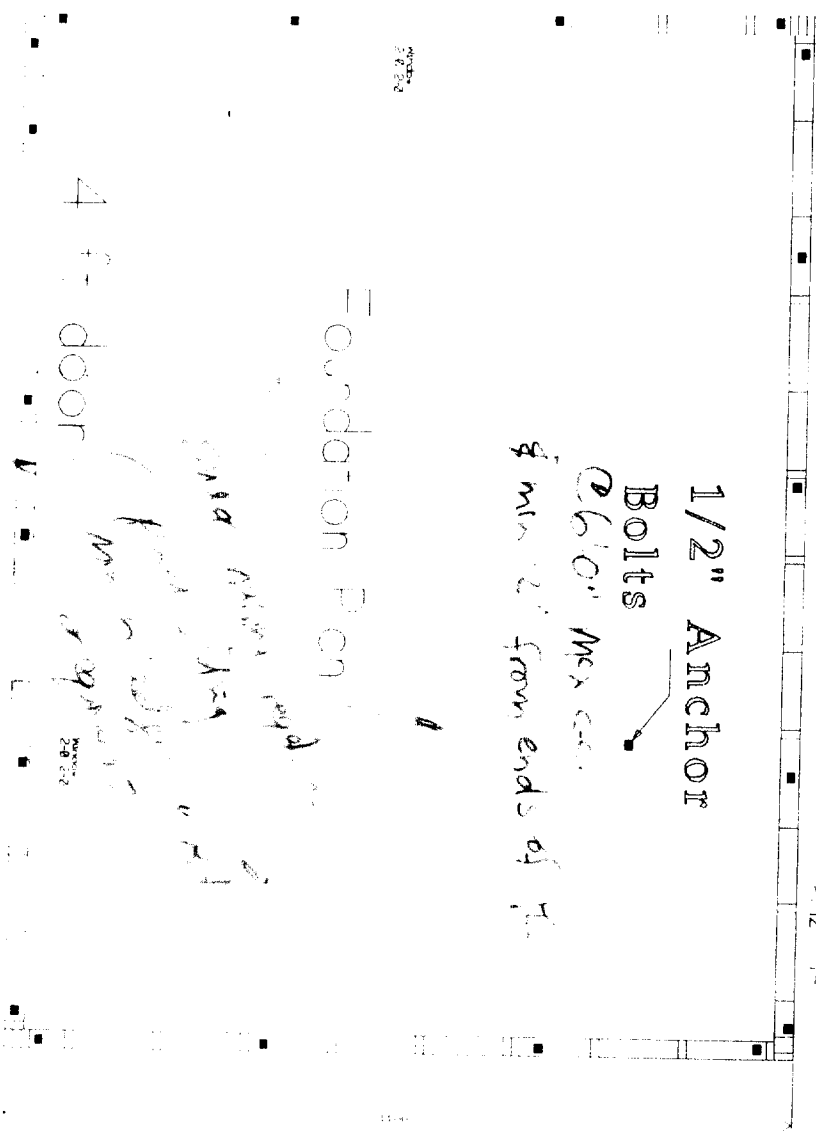

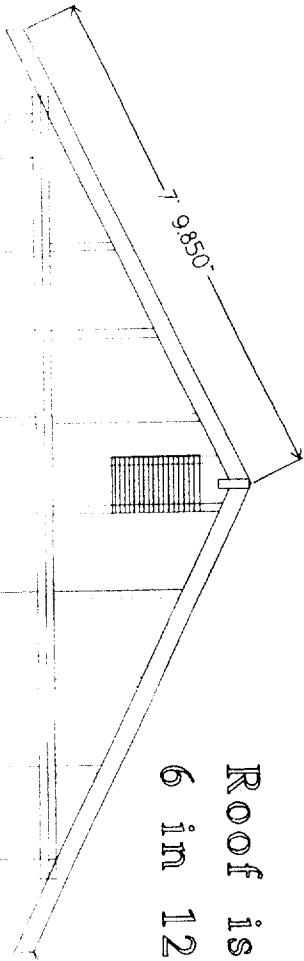

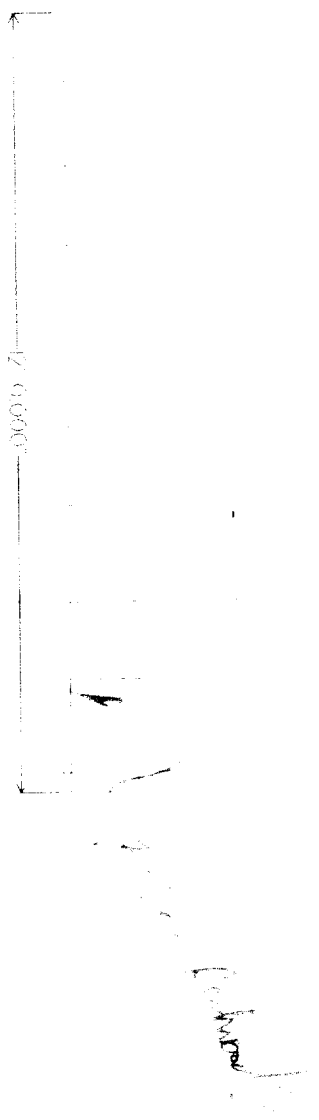


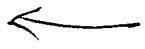
Figure of the Frame
