The Honorable City Council met in Special Session on this date at the hour of 3:05 o'clock p.m., Vice Mayor Christensen presiding and roll call was answered as follows:

Executed copies of the call of the meeting issued by the Mayor and presented by the City Clerk, were ordered filed.

The call stated the purpose of the meeting to be that of considering building construction regulations in the 'Old Sacramento Historical Area'', and to present such other matters as may regularly come before said body or be presented by the City Manager.

Acting City Manager E. A. Fairbairn outlined the reason for this instant special meeting advising that it was prompted by the request of Mr. Bob McCabe, Architect, for permission to build a covered walkway over City sidewalk at the southwest corner of 2nd and K Streets in the "Old Sacramento Historical Area", in connection with the proposed opening of Betty Blake's Ice Cream Parlor at said location.

A lengthy discussion of the many building problems which may arise in the development of the Historical Area thereupon ensued.

Mr. Clyde Trudell, Historical Area Project Manager for the Redevelopment Agency, appeared and informed the Council that the Agency will cooperate in any way the City wishes and will go along with all City requirements, further advising that their particular concern is preserving the architectural fronts of buildings of historical significance.

Following further discussion on the over-all matter, it was the consensus of the Council that installation of covered walkways in the "Old Sacramento Area" would be favorably considered but that no action on Mr. McCabe's request be taken until receipt of the final report on the Historical Area being prepared by Candued and Fleissig.
