REPORTS OF DIRECTOR OF PERSONNEL

Letter re Classification Title of  
Curator of Education

Mrs. Donna L. Giles, Director of Personnel, addressed the Board and referred to a letter from Richard V. West, Director of the Crocker Art Museum, regarding the title of Curator of Education. This issue had been raised at the regular Civil Service Board meeting of September 15, 1981, and concern had been expressed on the title being too general. The Board expressed satisfaction with the explanation contain in Mr. West's letter.

ESTABLISHMENT OF NEW CLASSIFICATION - LITTER CONTROL AIDE -  
First Reading

Susan Davidson, Associate Personnel Analyst addressed the Board and referred to the expansion of the Waste Removal Division to augment the litter control function. Ms. Davidson referred to the recent establishment of the position of Litter Control Officer, and informed the Board the the proposed new position of Litter Control Aide would be to assist that position.

There was some discussion on this proposed position and Mr. Mayhew questioned the funding, and Mr. Russell questioned two items on the job classification:

1. Under - Supervision Received and Exercised:

Should the word "Immediate" be changed to "Direct", and

2. Under - Qualifications:

Complete the American Red Cross Standard First Aid Course during the probationary period.

There was some question on the necessity for this first aid course, and Mr. Reginald Young, Waste Removal Superintendent, addressed the Board and stated the desirability for this type of training for a uniformed City employee.

Motion was made to approve the establishment of a new classification - Litter Control Aide, and to pass for second reading.

Motion was approved by unanimous roll call vote.


