- I. The regular meeting of the Sacramento Metropolitan Arts Commission was called to order by Chair Williams at 4:05 pm at the Coloma Community Center.
- II. It was moved by Davidson and seconded by Bell that the agenda be approved as written. The vote was unanimous.
- III. It was moved by Payne and seconded by Davidson that the minutes of the August 9, 1989 regular meeting be approved as written. The vote was unanimous.

- VI. Consent Calendar  
It was moved by Commissioner Gordon and seconded by Commissioner Morris to approve the consent calendar items. Commissioner Randlett abstained from item A; the vote was otherwise unanimous.
- VII. Action Items
  - A. Vote on Arts Commission Response Regarding Arts in Education Charge  
This item was removed from the agenda.

B. Vote on Two Major Charges to Arts in Education Committee

It was moved by Commissioner Randlett and seconded by Commissioner Gordon to accept as the two major charges for the Arts in Education Committee: 1) Research ways to fund directory and 2) Commitment to the Children's Festival. The vote was unanimous.

C. Vote on City Use of \$25,000 to Support "New Works Program"

It was moved by Commissioner Wang and seconded that the Commission support the concept of using the first \$25,000 to support the New Works program and that the guidelines of the program be changed to emphasize multicultural new works and that an evaluation point system be included to favor multicultural new works. The vote was unanimous.

D. Vote on Arts Commission Position on Admissions Tax

It was moved by Commissioner Wang and seconded by Commissioner Morris to accept the Arts Commission position as written. The vote was unanimous.

Chair Williams reported on the admissions tax discussions.

IX. Director's Report

Arts Program Assistant Kim Heckes will take over as Program Coordinator in Mary Lynn Perry's absence as of September 18, 1989. Director Ceccherelli will be out of town October 5 through October 17. Opportunity coming to review Art in Public Places ordinances. Jerry Allen to come as consultant as a part of this review.
