- Violation:** Provide approved type and installation of room heater which will maintain a temperature of 70 degrees three (3) feet above the floor. 8.100.490 **Status:** Open
- Comments:** Proof heater is in working order required. Inspection of interior required.
- Violation:** Provide replacement of deteriorated plumbing fixtures with approved type. 8.100.600 **Status:** Open
- Comments:** To verify plumbing meets minimum code, interior inspection is required.
- Violation:** Other **Status:** Open
- Comments:** This list may be incomplete and does not exclude any code violations which become apparent during further inspections or during the necessary rehab/repair work. Building Permits are required.

- Violation:** General dilapidation or improper maintenance of the building. 8.100.560 **Status:** Open
- Comments:** Exterior is weathered, in need of improvement
- Violation:** Deteriorated or ineffective waterproofing of exterior walls, roof, foundation or floors including broken windows or doors. 8.100.470 **Status:** Open
- Comments:** Siding appears in poor shape, in need of repair. Area noted where siding is missing and or broken.
- Violation:** Defective or lack of weather protection for exterior walls including lack of paint or weathering due to lack of paint or other approved protective covering. 8.100.470 **Status:** Open
- Comments:** Siding is in need of repair and paint. Item number B17 should include roof maintenance is needed.
- Violation:** Unsafe electrical service equipment. 8.100.500 **Status:** Open
- Comments:** Electrical main panel, inspection required. It appears open, and if damaged, and or vandalized, repairs are required. Access to rear yard and interior property inspection required for inspection.
