**SUBJECT:** RESOLUTION APPROVING CATEGORIC EXEMPTION AND AWARD OF CONTRACT IN THE AMOUNT OF \$173,960 TO WESTCON CONSTRUCTION FOR THE ROBLA SECURITY ENCLOSURE CONSTRUCTION PROJECT (ZD61)

**LOCATION AND DISTRICT:**

4401 Bell Avenue - Council District #2

**RECOMMENDATION:**

This report recommends that the City Council:

- Adopt the attached resolution approving a project categoric exemption under the California Environmental Quality Act;
- Accept the bid of Westcon Construction in the amount of \$173,960 for the City Robla Security Enclosure Construction Project; and
- Authorize the City Manager to execute a contract.

**SUMMARY:**

This project was funded and will provide the required security enclosure and yard lighting for City Utilities Department's North Area Equipment Storage Yard at the Robla Reservoir, corner of Bell Avenue and Rio Linda Blvd.

**BACKGROUND INFORMATION:**

On July 26, 1995, advertisement for receipt of bids was issued. On August 30, 1995, six bids were received.

The bids received are:

The construction estimate is \$181,000.

Westcon Construction submitted the lowest responsible bid for the base bid and is recommended for award.

**FINANCIAL CONSIDERATIONS:**

- The project budget for Robla Security Enclosure Project (ZD61) is \$249,936.
- The unobligated fund balance as of 8/30/95 is \$1,499,199, which is sufficient for award.

**ENVIRONMENTAL CONSIDERATIONS:**

The Planning Services Division, Environmental Section, has reviewed the project and has determined that this project exempt from the California Environmental Quality Act (CEQA) under Section 15301(a),(e)(2) of the CEQA Guidelines. Upon approval of the attached Resolution, a Notice of Determination will be filed with the Sacramento County Clerk.

**POLICY CONSIDERATIONS:**

The actions requested herein are consistent with Title 58, Sacramento City Code.



**MBE/WBE EFFORTS:**


Of the six bids received, Paschal & Tanaka is a City certified MBE. To encourage minority participation, plans and specifications were sent to 9 plan rooms and construction services organization for publication. Four were directly involved with MBE/WBE construction firms. Staff recruited available MBE/WBE firms to participate in the bid process. The project was announced on the City of Sacramento Project Information Line which contains information on Public Works and Utility Department projects. Project notices were sent to 29 organizations involved in MBE/WBE recruitment.
