





SUBJECT: ALTERNATIVE TO DIRECT HAUL PROPOSERS' SELECTION EVALUATION
CRITERIA

SUMMARY

This report recommends that the City Council approve the evaluation criteria established by the Committee to select proponents to the Alternative to Direct Haul of Municipal Solid Waste.

BACKGROUND

On April 17, 1990, the City Council informed staff that the Alternative to Direct Haul's Selection Committee, in making its ultimate selection among proposals that meet the criteria (the six firms invited to submit proposals), will give weight to the following factors: tipping fee, financial risk, performance in recovery of recyclables, landfill avoidance, and environmental impacts, as well as the ability to support the City's efforts to meet its AB 939 requirements.

In response to the Council's direction, the Selection Committee has established proponent selection evaluation criteria as follows:

RFQ Response (Previously Rated)	10%
Cost Proposal Response	70%
Proponents Interview	10%
Site Visit	10%

The Selection Committee has also prescribed relative importance to elements of the proposal evaluation as shown on attached Table 1.

FINANCIAL DATA

POLICY CONSIDERATIONS

The Selection Committee's actions are consistent with the direction of the City Council.




