SUBJECT: SUMMER YOUTH EMPLOYMENT PROGRAM

SUMMARY

This report provides information on the 1990 Summer Youth Employment Program. In addition, this report recommends that the City Council authorize the City Manager to submit a grant for the 1991 Summer Youth Employment Program to the Sacramento Employment and Training Agency.

BACKGROUND INFORMATION

The Office of Human Services, Parks and Recreation City-wide, has been an operator of the Summer Youth Employment Program since 1985. The Sacramento Employment and Training Agency administers the federally funded SYETP/JTPA Title II-B Program. As one of many program operators, the Office of Human Services coordinates the placement of 120 eligible youth in various City Departments. Included within this is a program for Developmentally Disabled young people who work under close supervision in crews of four and gain similar work experience as do other participants in the program. This special needs program is, to our knowledge, the only one on the West Coast.

The attached report (Exhibit A) provides an overview of the 1990 program including appropriate statistical information.

FINANCIAL DATA

As noted in the overview report, no City funds are required. All costs associated with this program are reimbursed from the grant. No matching funds are required.

POLICY CONSIDERATIONS

The Summer Youth Employment Program is consistent with the Department's goal to provide and/or facilitate programs and services that enrich the quality of life for individuals and groups with specialized needs.





1990 Summer Youth Employment and Training Program

The Summer Youth Employment & Training Program (SYETP) is funded under Title II-B of the Federal Job Training Partnership Act and provides summer employment for unemployed, disadvantaged youth between the ages of 14 and 21. The City of Sacramento Office of Human Services provides the coordination, identifies the work sites and work projects as well as supervises the participant's work performance.

The Sacramento Employment and Training Agency (SETA), as the Program Administrator under the Job Training Partnership Act is responsible for overall planning and program development including the allocation of funds and the selection of project sponsors.

The specific objectives of the SYETP are:

- 1) To provide participants with an opportunity to gain good work experience and to develop useful work behavior patterns and basic skills.
- 2) To provide financial assistance to youth between the ages of 14 and 21 who qualify under Federal economic Guidelines.
- 3) To produce useful services and improvements for the youth of our City and County.

As part of the summer program, a labor market orientation is provided to all participants. This orientation is provided by program staff on a group basis. The purpose of this LMO is to provide youth with information regarding the local labor market and an understanding of how they may participate within this market. The information disseminated in the LMO training provide program participants with the following:

- 1) Information regarding the local labor market and types of jobs available.
- 2) Job search information and methods that will be useful when looking for work.
- 3) Information that will be useful when enrolling at local colleges.
- 4) Information regarding military programs.

This workshop is conducted as part of the participants orientation process prior to actual on-site job placement.

Developmentally Disabled

Integrated into the SYETP is the youth employment program for the developmentally disabled. As the only such program on the West coast, this program provides work opportunities for twenty Sacramento disabled youth. This program provided opportunities for participants to learn job skills and gain work experience necessary to assist them to fit into the normal work force.

During the 1990 program, youth were placed at four sites:

- 1) Sacramento Zoo/Fairytale Town
- 2) City Cemetery
- 3) Miller Park
- 4) City Nursery

In order to provide proper supervision a "work crew" concept has been developed. Participants work in groups of five each at the four sites. A crew leader is assigned to each location.
