Recommendation: Adopt a **Resolution** authorizing the City Manager or the City Manager's designee to execute Contract Supplement No. 1 to Contract No. 2008-200 with Walton Engineering, Inc. for fuel site compliance services for the City's fuel storage and dispensing sites in an amount not to exceed \$95,000 for a revised total contract amount not to exceed \$250,000.

Description/Analysis:

Issue: The Department of General Services, Fleet Management Division, has an ongoing need for fuel site compliance services (testing, maintenance, monitoring, and reporting) to maintain compliance with governmental regulations.

Policy Considerations: The recommendations in this report are in accordance with the provisions of City Code Section 3.56, and Resolution 2010-346 prohibiting the City from entering into any contract to purchase goods or services from any business or entity headquartered in Arizona.

Environmental Considerations:


California Environmental Quality Act (CEQA): The Environmental Services Manager has determined that fuel site compliance services do not have the potential for causing a significant adverse effect on the environment and are therefore exempt under CEQA Guidelines, Section 15061(b)(3).


Sustainability Considerations: Executing a contract supplement with Walton Engineering, Inc. will provide sufficient funding to continue with fuel site compliance services which is consistent with the Sustainability Master Plan goal to "...protect the sources of water".

Rationale for Recommendation: On August 7, 2008, City Council adopted Resolution No. 2008-546, awarding a one-year contract with two one-year renewal options to Walton Engineering, Inc. for fuel site compliance services. The City must now replace four existing diesel fuel dispensers, and there is a potential need to install an above ground gasoline storage tank at the City's Emergency Vehicle Operations Center. Due to an unanticipated volume of work performed under this contract, expenses are approaching the dollar limit of the original award. Executing Contract Supplement No. 1 with Walton Engineering, Inc. will provide sufficient contract authority for the compliance services associated with this work and for additional work through the end of the contract term.



Emerging Small Business Development (ESBD): Walton Engineering, Inc. is not certified as an emerging/small business.


